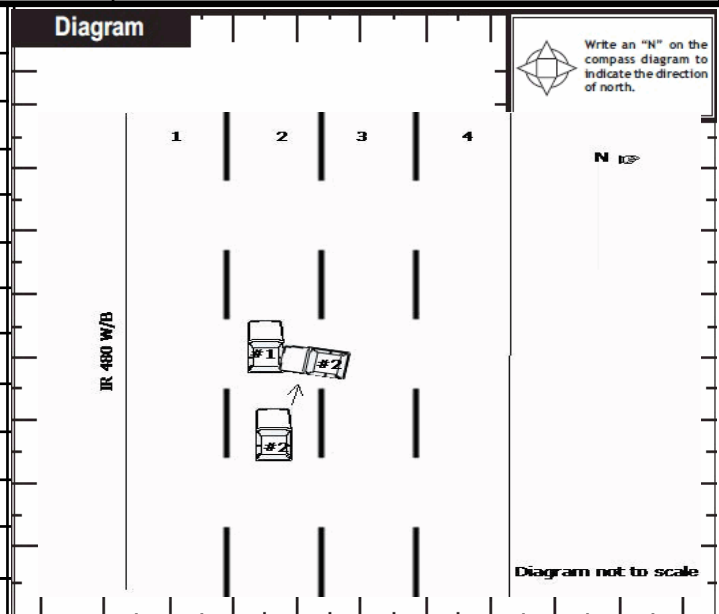

UNIT #1 WAS TRAVELING WEST ON I480 JUST PAST MILE POST 24/4 IN LANE #1, UNIT #2 WAS TRAVELING WEST ON I480 IN LANE #1 WHEN ANOTHER VEHICLE DESCRIBED AS A BLACK INFINITY SUV BEGAN APPROACHING THEM FROM BEHIND AND WAS ERRATICALLY CROSSING IN AND OUT OF LANES. BOTH UNITS THEN CHANGED LANES TO LET THE INFINITY PASS. THE INFINITY THEN GOT IN FRONT OF UNIT #1 AND BEGAN TO SLOW CAUSING UNIT #1 TO START BRAKING. UNIT #2 THEN BEGAN BRAKING AND TRIED TO AVOID STRIKING UNIT #1 BY CHANGING LANES. UNIT #2'S BRAKES LOCKED UP CAUSING THE DRIVER TO TURN SIDWAYS AND HE THEN STRUCK UNIT #1 ON IT'S

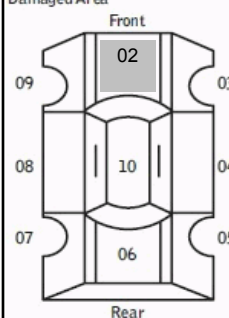
