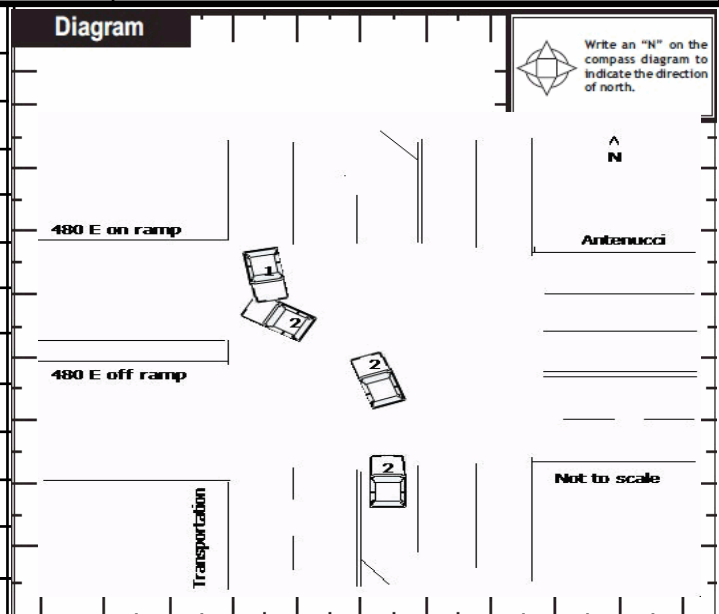

DRIVER OF UNIT 1 STATES THAT HE WAS TRAVELING S/B ON TRANSPORTATION AND AS HE PASSED THROUGH THE INTERSECTION NEAR THE 480 RAMPS UNIT 2 PROCEEDED TO MAKE A LEFT TURN IN FRONT OF UNIT 1 CAUSING THE TWO UNITS TO COLLIDE.

DRIVER OF UNIT 2 STATES SHE WAS TRAVELING N/B ON TRANSPORTATION AND BELIEVED UNIT 1 WAS MAKING A RIGHT TURN TO ENTER THE FREEWAY ON RAMP. UNIT 2 PROCEEDED TO MAKE A LEFT TURN ENTERING UNIT 1 LANE OF TRAVEL AND CAUSING THE TWO VEHICLES TO COLLIDE.
