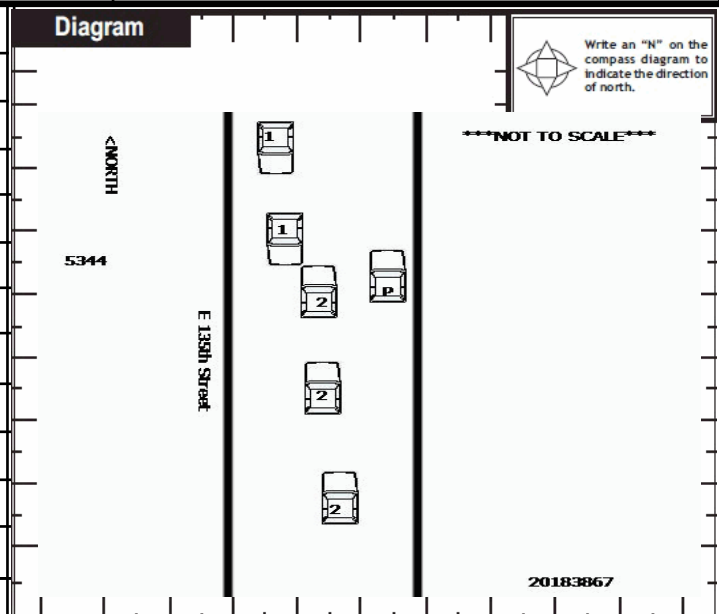

DRIVER OF UNIT 1 STATES THAT HE WAS HEADING S/B ON E.135TH STREET NEAR 5344 WHEN UNIT 2, WHICH WAS TRAVELING N/B, ATTEMPTED TO PASS A PARKED CAR FAILING TO YIELD TO UNIT 1. UNIT 2 WAS LEFT OF CENTER AT WHICH TIME UNIT 1 AND UNIT 2 STRUCK EACH OTHER.

DRIVER OF UNIT 2 STATES THAT HE WAS PASSING THE PARKED CAR BUT UNIT 1 SPED UP AND STRUCK HIM AS HE WAS STOPPED NEXT TO THE PARKED CAR. DRIVER OF UNIT 2 STATED HE STOPPED NEXT TO THE PARKED CAR BECAUSE HE DIDN'T HAVE ENOUGH ROOM TO MAKE




