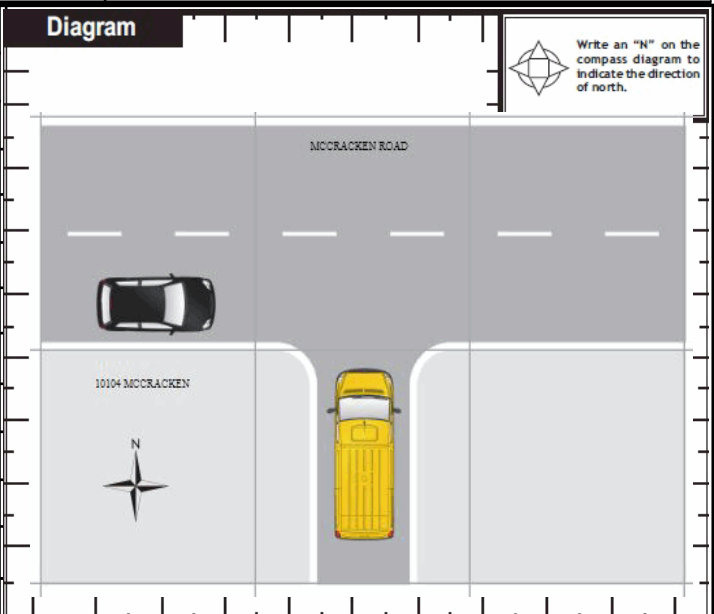

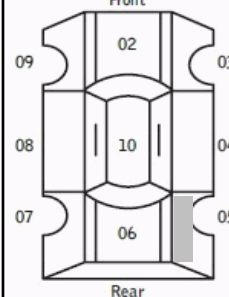

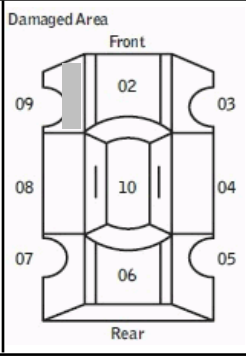

<p>Driver of unit #1 stated he pulled into the driveway of 10104 McCracken Rd, traveling from East to West. Driver of Unit #1 stated he observed Unit #2 which was parked in front of 10104 McCracken Rd. Unit #1 is a bright yellow utility van with fresh damage (deep scratch) and black paint transfer on the passenger rear of Unit #1. Driver of Unit #1 stated he was the only person to drive Unit #1 and he denies any and all knowledge of striking Unit #2 and stated that he backed into the driveway without hitting the parked car.</p> <p>Owner of Unit #2 stated his auto was parked in the roadway and unoccupied in front of 10104 McCracken Rd. Unit #2 is a black spray painted compact car. Unit #2 had fresh damage (scratches) and bright yellow paint transfer on the left front wheel well.</p> <p>Unable to determine what actually happened but the damage to both Units is inconsistent with the story given by the driver of Unit #1.</p>
