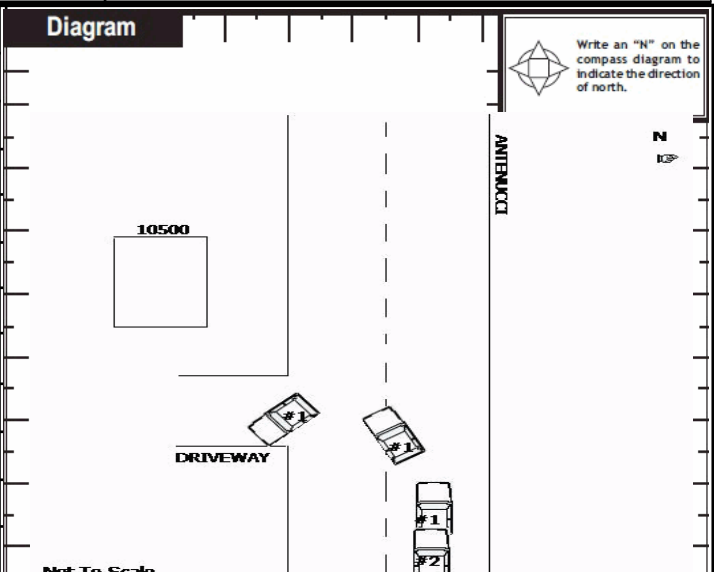

UNIT #1 WAS TRAVELING WEST ON ANTENUCCI AND WAS STRUCK IN THE REAR BY UNIT #2. THE TWO REAR PASSENGER WERE COMPLAINING OF BACK AND NECK PAIN AND WERE BOTH TRANSPORTED TO MARYMOUNT. UNIT #2 WAS TRAVELING WEST ON ANTENUCCI AND STRUCK THE REAR OF UNIT #1 WITH THE FRONT CENTER OF UNIT #2. DRIVER OF UNIT #2 STATED HE WAS TRYING TO SLOW DOWN BUT HE BELIEVES HIS BRAKES WENT OUT CAUSING HIM TO STRIKE UNIT #1
