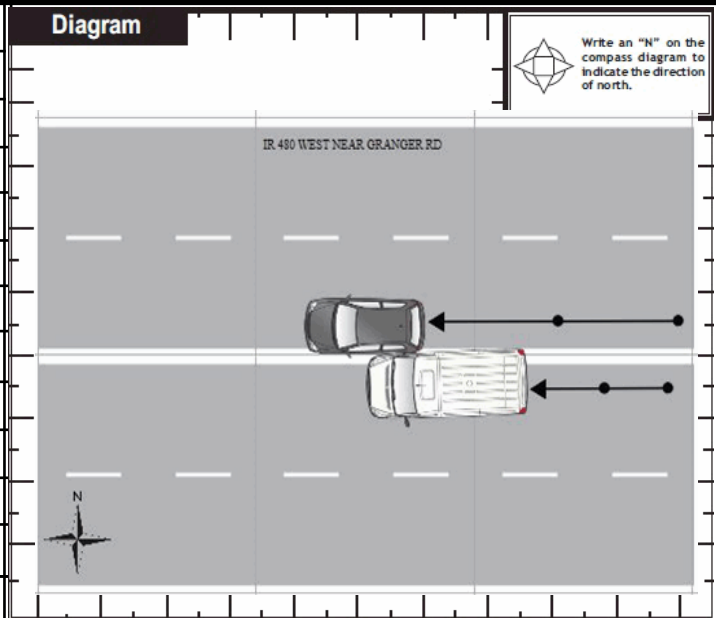

DRIVER OF UNIT #2 STATED HE WAS TRAVELING ON IR 480 WEST NEAR GRANGER RD IN LANE #3. DRIVER OF UNIT #2 STATED HE LOOKED UP AND BELIEVED THAT UNIT #1 HAD ENTERED HIS LANE AND STRUCK HIS VEHICLE ON THE LEFT SIDE.


