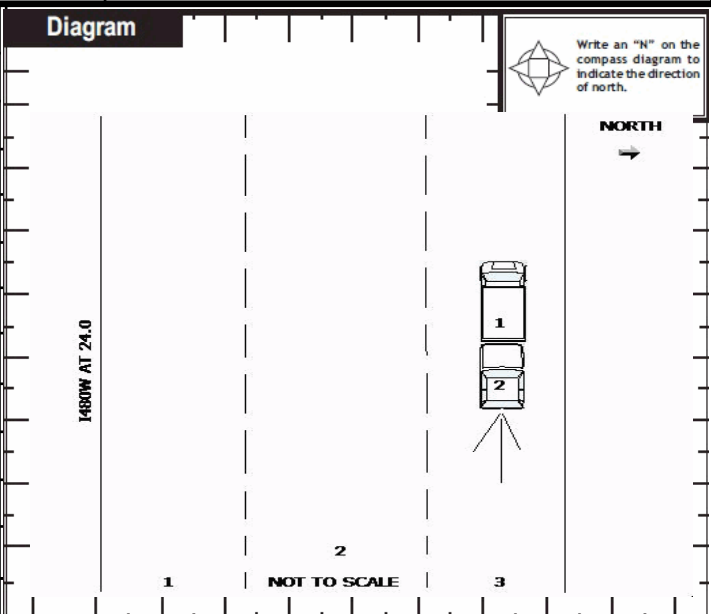

**Narrative**

UNIT 1, A TOW TRUCK TOWING TWO VEHICLES ONE ON THE FLAT BED ONE BEHIND THE TRUCK, WAS TRAVELING WESTBOUND ON I480 AT MILE POST 24.0 IN THE #3 LANE. UNIT 2 WAS TRAVELING DIRECTLY BEHIND UNIT 1. UNIT 1 BEGAN TO SLOW FOR STOPPED TRAFFIC AND UNIT 2 FAILED TO MAINTAIN AN ASSURED CLEAR DISTANCE AND STRUCK THE VEHICLE UNIT 1 WAS TOWING WITH THE CENTER FRONT OF UNIT 2. UNIT 2 STOPPED FOR A SHORT PERIOD OF TIME BUT THEN FLED THE SCENE. THE OPERATOR OF UNIT 2 IS DESCRIBED AS A WHITE MALE 40 -50 YOA.
