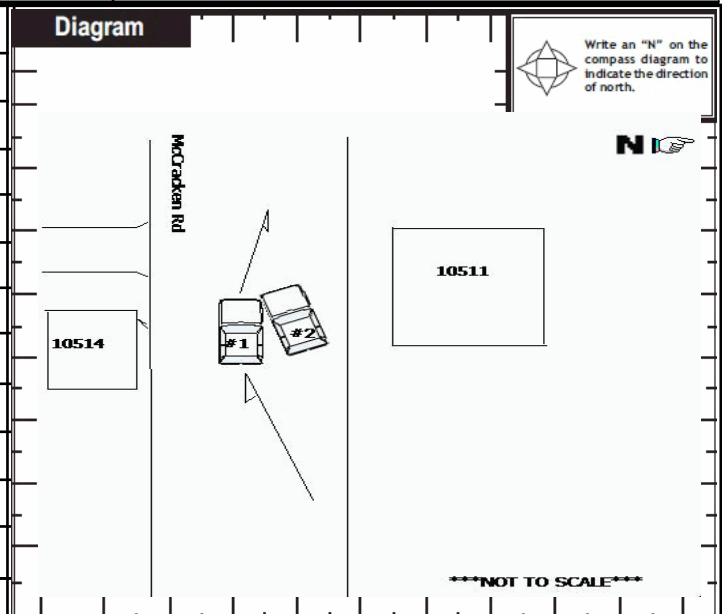

UNIT 2 STATES HE WAS TRAVELING W/B ON MCCRACKEN, STOPPED, AND PREPARING TO TURN LEFT INTO HIS DRIVEWAY AT 10514 MCCRACKEN. AS UNIT 2 BEGAN TO TURN UNIT 1 BEGAN TO PASS ON THE LEFT SIDE OF UNIT 2. UNIT 1 STRUCK UNIT 2 AT THE FRONT LEFT. UNIT 2 DID STATE HE FAILED TO SIGNAL PRIOR TO THE TURN. UNIT 1 STATED SHE BELIEVED UNIT 2 WAS PARKING ON THE STREET DUE TO THE LACK OF A SIGNAL AND THE VEHICLE'S PROXIMITY TO THE CURB. UPON ARRIVAL THIS OFFICER OBSERVED THAT UNIT 2 WAS STILL WITHIN THE TRAFFIC LANE OF TRAVEL OVER 1 FOOT FROM THE CURB




