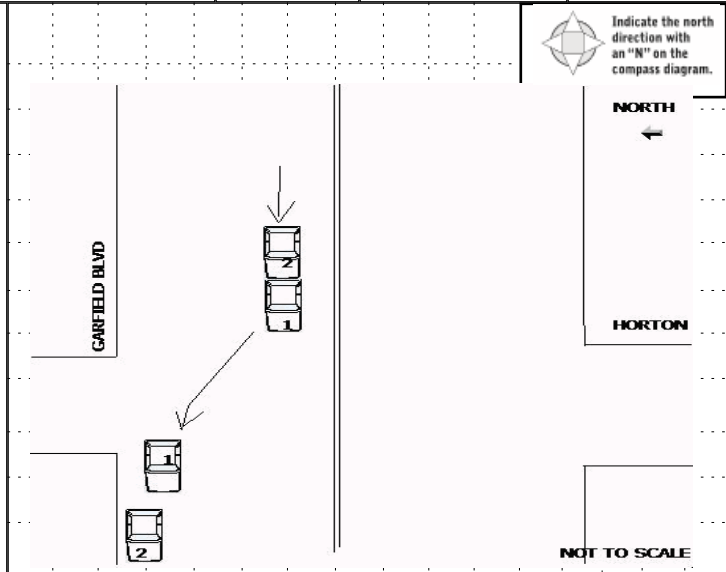

OPERATOR OF UNIT 1 STATED HE WAS WESTBOUND ON GARFIELD BLVD STOPPED AT HORTON WAITING TO MAKE A LEFT TURN. UNIT 2 WAS TRAVELING WESTBOUND ON GARFIELD BLVD DIRECTLY BEHIND UNIT 1. UNIT 2 FAILED TO MAINTAIN AN ASSURED CLEAR DISTANCE AND STRUCK UNIT 1 IN THE CENTER REAR WITH THE CENTER FRONT OF UNIT 2. THE OPERATOR OF UNIT 2 THEN FLED THE SCENE ON FOOT EASTBOUND ON GARFIELD BLVD.

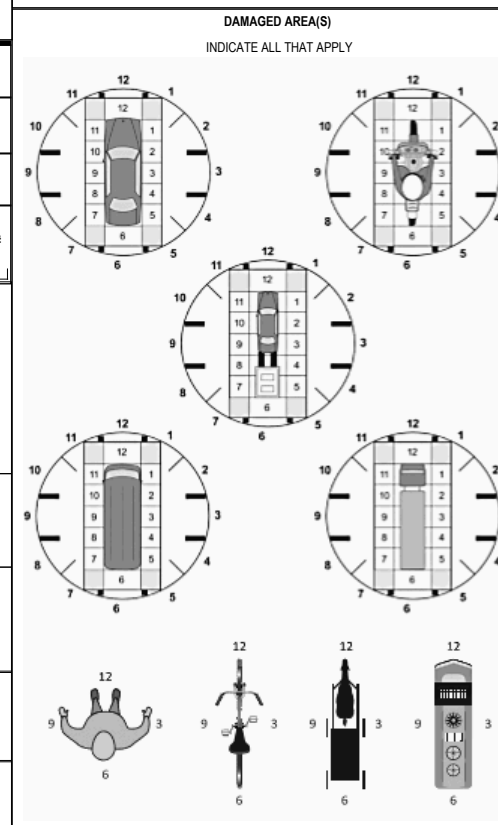

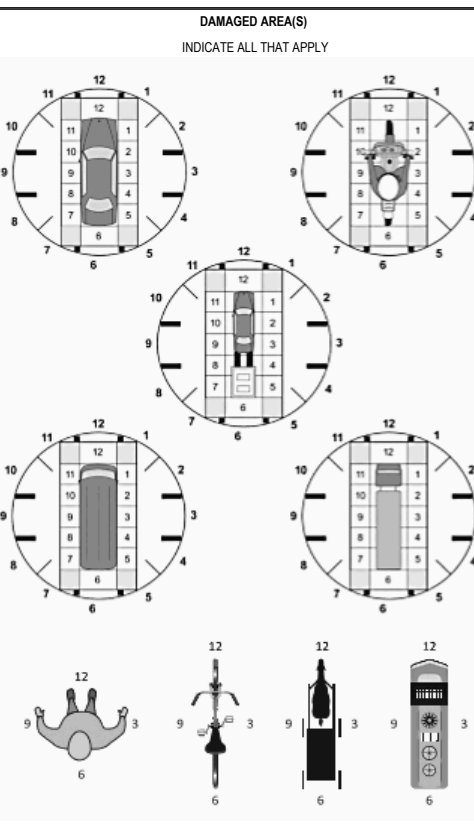
