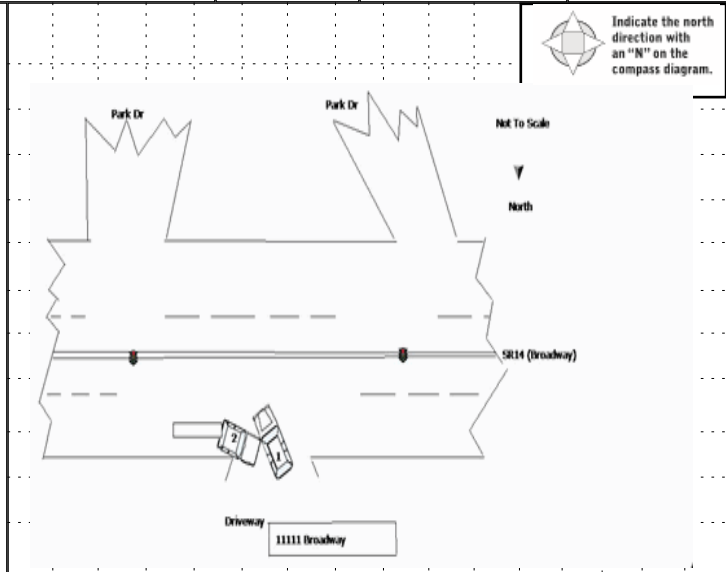
NARRATIVE

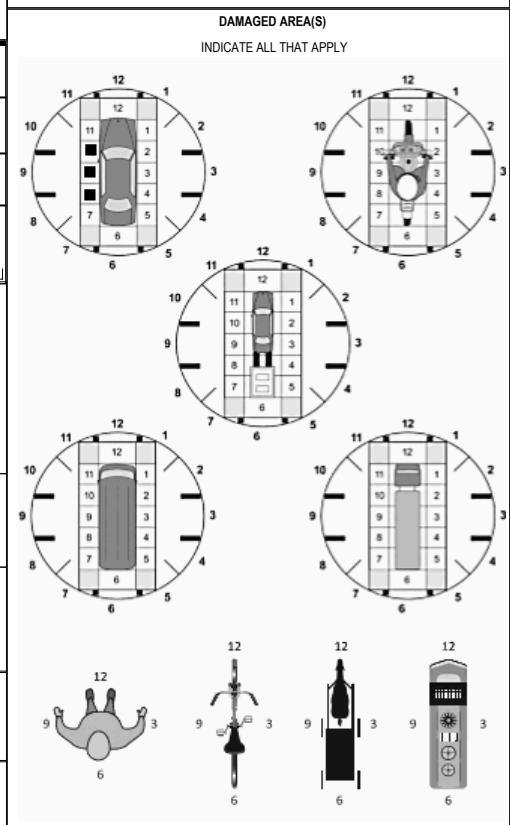
