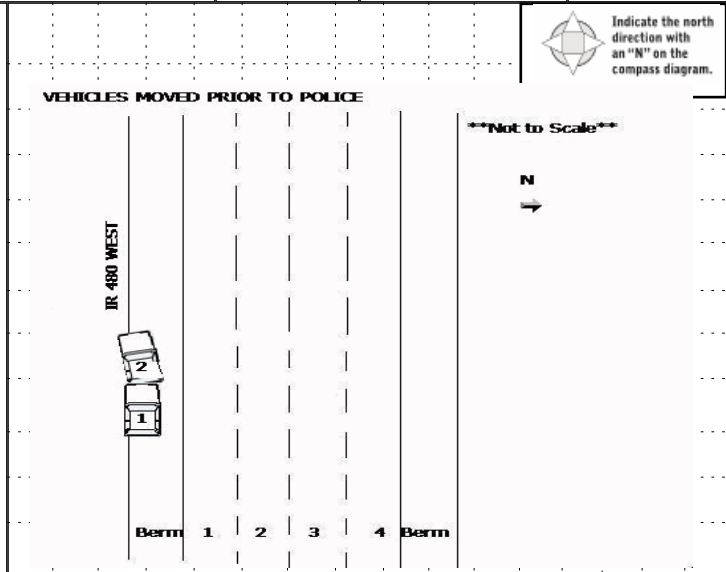

HE SAW UNIT #2 SPUN OUT HIT THE GUARD RAIL FROM A DISTANCE. HE HIT HIS BRAKES AND STATED HIS VEHICLE SKIDDED ON THE BLACK ICE. UNIT #1 STRUCK UNIT #2 FROM BEHIND.

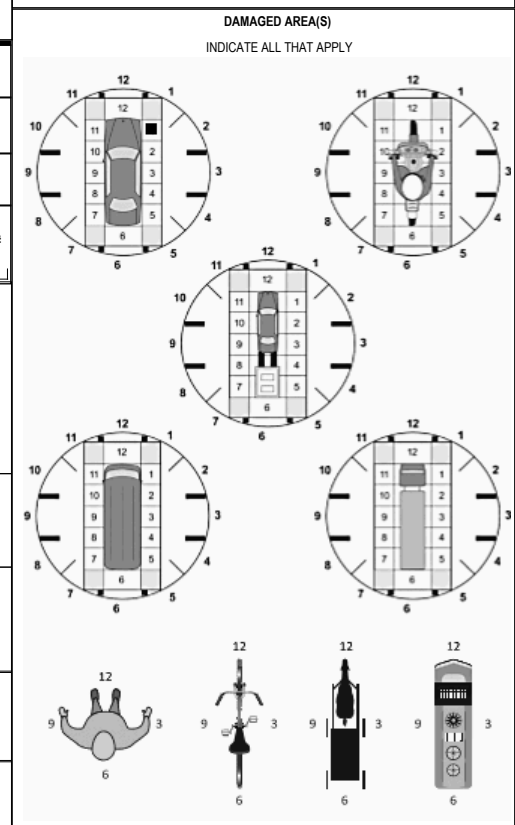
