UNIT 1 THEN DROVE ACROSS THE ROADWAY TO THE LEFT AND CAME TO REST IN THE FRONT YARD OF 10212. CRASH CAUSED THE UTILITY POLE TO SPLIT IN HALF AND FALL TO THE GROUND. 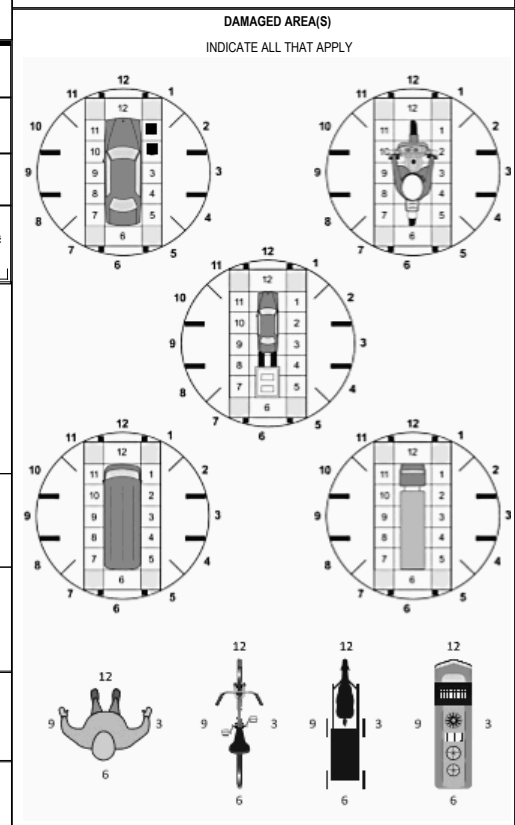
