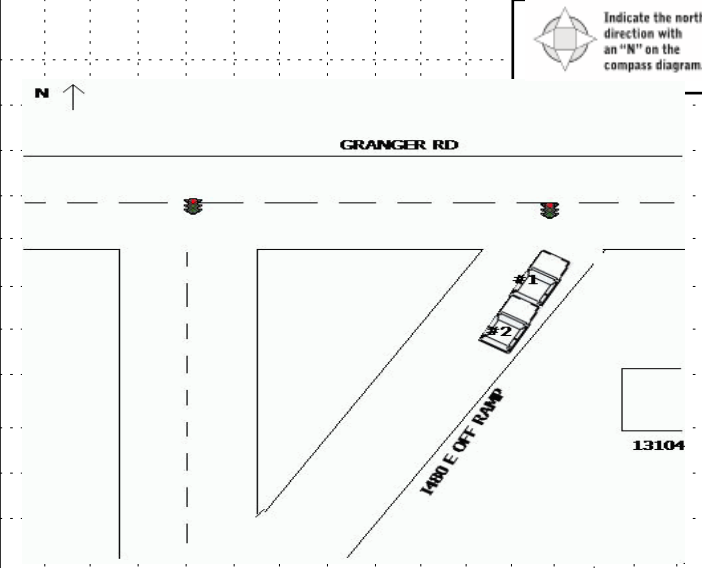

 UNIT #1 WAS TRAVELING NORTH DOWN THE I480 RAMP TO GRANGER RD. UNIT #1 THEN CAME TO A STOP AT THE LIGHT TO TURN EAST AND WAS STRUCK IN THE REAR BY UNIT #2. THERE WAS MINOR DAMAGE TO THE REAR BUMPER OF UNIT #1. THE DRIVER OF UNIT #2 STATED AS SHE WAS EXITING I480 UNIT #1 APPROACHED THE LIGHT AND APPEARED TO BE CONTINUING THROUGH BUT THEY ABRUPTLY STOPPED WITH NO TRAFFIC PASSING BY ON GRANGER. SHE THEN HIT THE REAR OF UNIT #1 WITH UNIT #2'S FRONT BUMPER CAUSING MINOR FRONT END DAMAGE.
