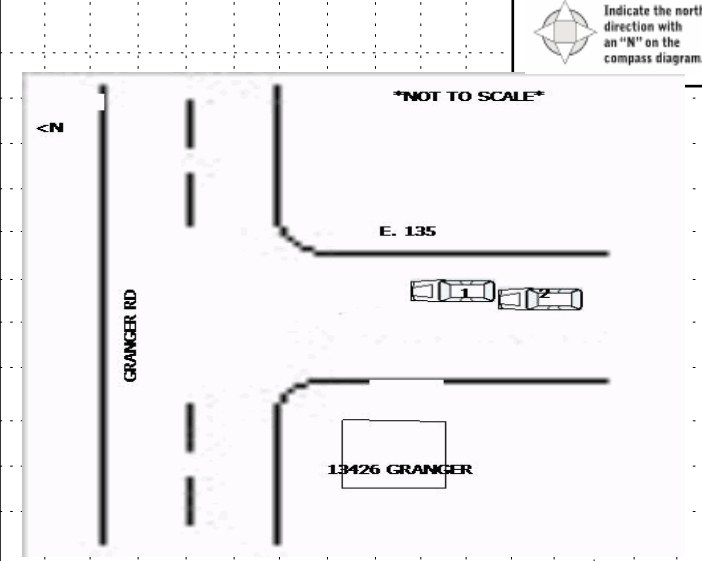

 UNIT 2 STATES THEY WERE TRAVELING NORTH ON E 135 APPROACHING GRANGER RD. UNIT 1 WAS BACKING ON E. 135 IN AN ATTEMPT TO PULL INTO THE DRIVE AT 13426 GRANGER. UNIT 1 CONTINUED BACKING INTO THE PATH OF UNIT 2 WHO COULD NOT STOP DUE TO BAD ROAD CONDITIONS.  
 UNIT 1 STATES THEY WERE COMPLETELY STOPPED WHEN UNIT 2 REAR ENDED THEM. NO INDEPENDENT WITNESS AVAILABLE. UNABLE TO DETERMINE FAULT AS BOTH STATEMENTS OF THE CIRCUMSTANCES ARE PLAUSIBLE.

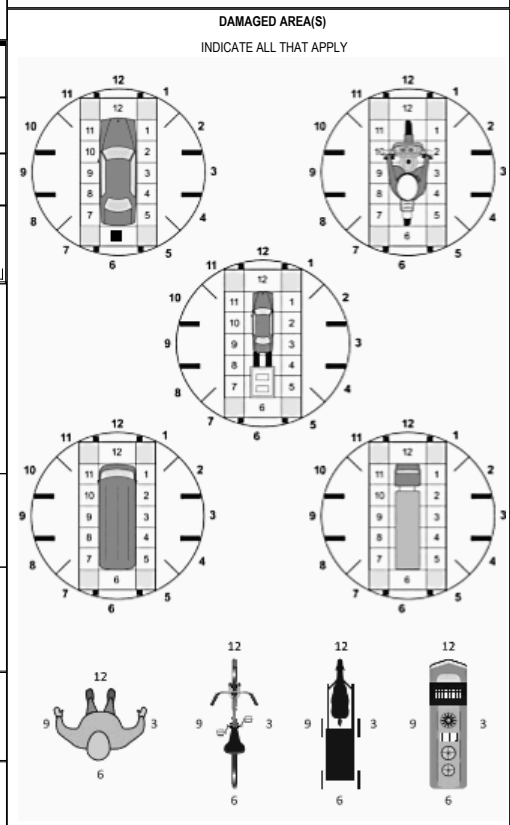

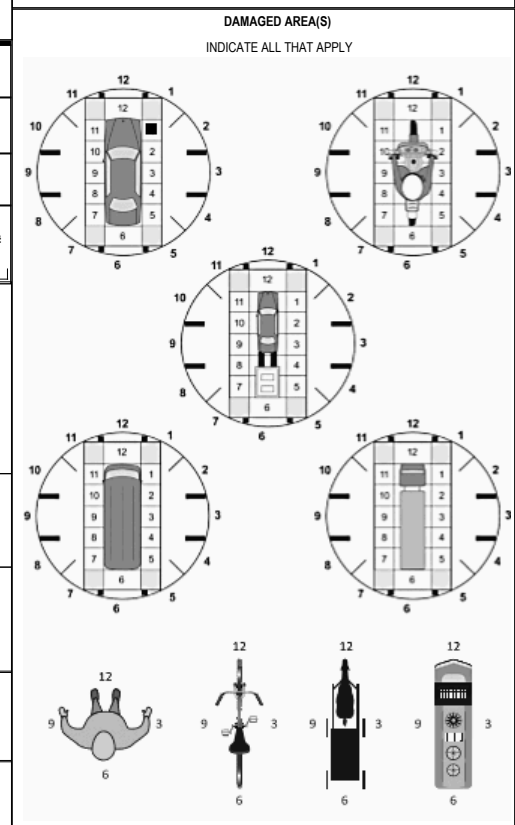
