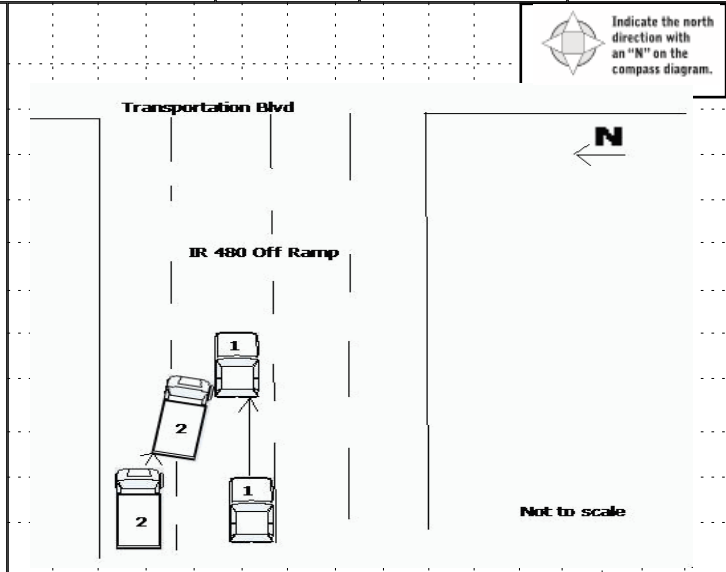

UNIT ONE WAS TRAVELING ON THE IR-480 EAST OFF RAMP TO TRANSPORTATION BLVD IN THE #2 LANE.

UNIT 2 WAS TRAVELING IN THE #1 LANE AND WAS IN FRONT OF UNIT ONE. AS UNIT TWO THEN ATTEMPTED TO MAKE A LANE CHANGE IN TO TH #2 LANE AND STRUCK UNIT ONE AS IT WAS PASSING.

UNIT TWO IS A CONSTRUCTION VEHICLE THAT HAD FLASHING YELLOW LIGHTS ILLUMINATED AT THE TIME OF THE CRASH. A MARKED POLICE VEHICLE WAS ALSO IN FRONT OF UNIT TWO WITH ITS RED AND BLUE LIGHTS ACTIVATED AT THE TIME OF THE CRASH.

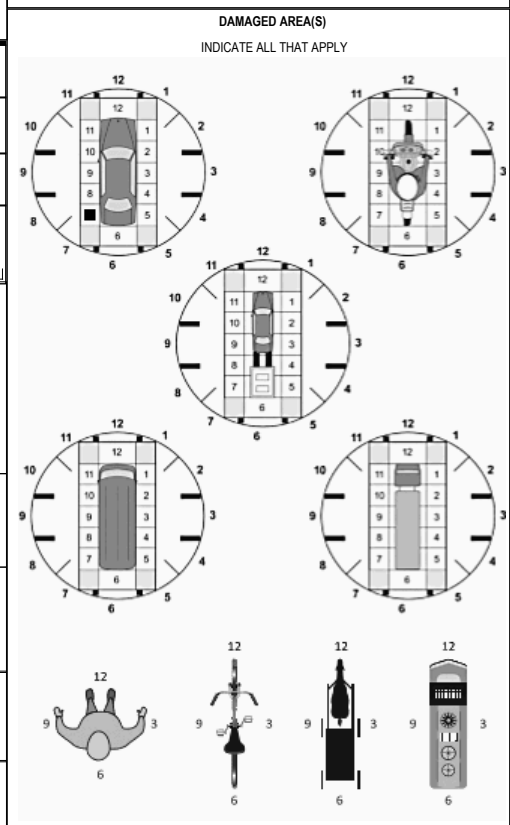
