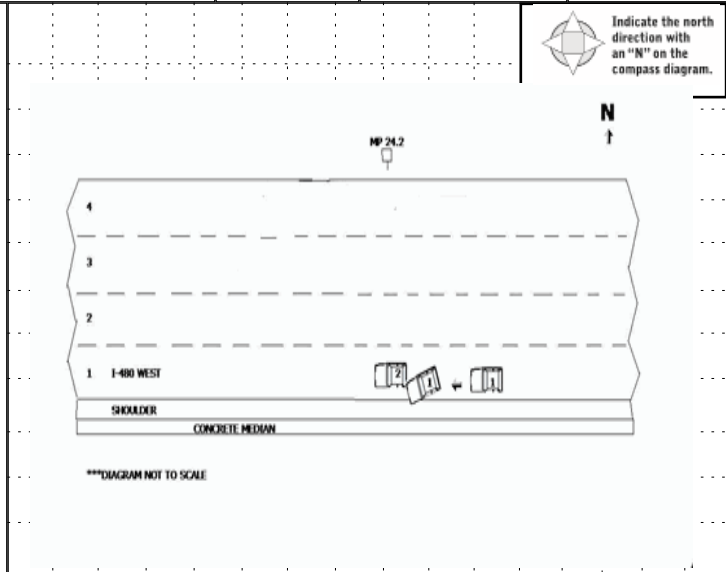

NARRATIVE

UNITS 1 AND 2 WERE TRAVELING ON I-480 WEST IN LANE 1. UNIT 2 WAS IN FRONT OF UNIT 1 AND WAS COMING TO A STOP FOR TRAFFIC. UNIT 1 FAILED TO STOP IN TIME AND TRIED TO AVOID A CRASH BUT STRUCK THE LEFT REAR SIDE OF UNIT 2 WITH THE RIGHT FRONT OF UNIT 1. UNIT 1 THEN DROVE OFF THE ROAD TO THE LEFT AND STRUCK THE CONCRETE MEDIAN. THE CRASH OCCURRED NEAR MILE POST 24.2.

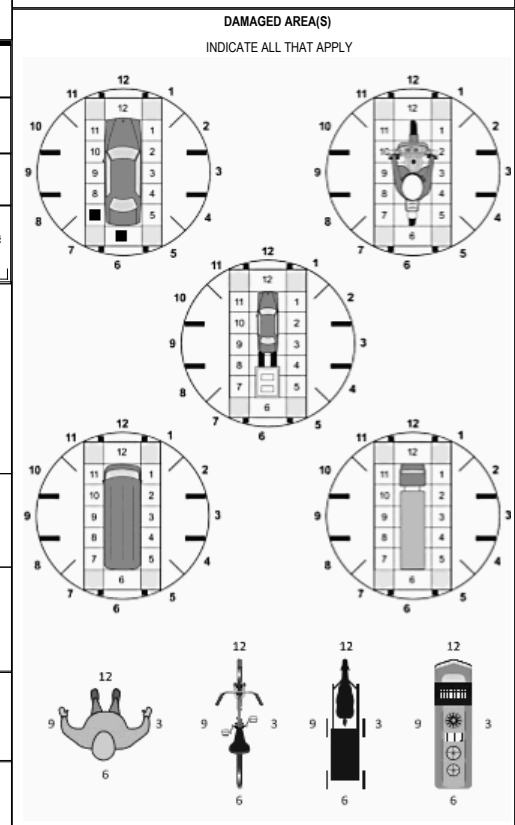

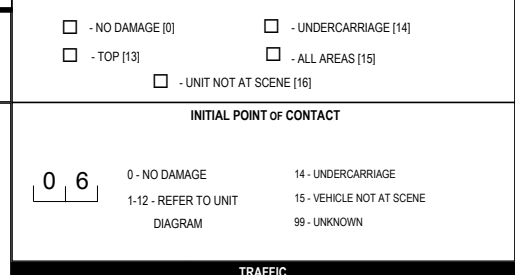

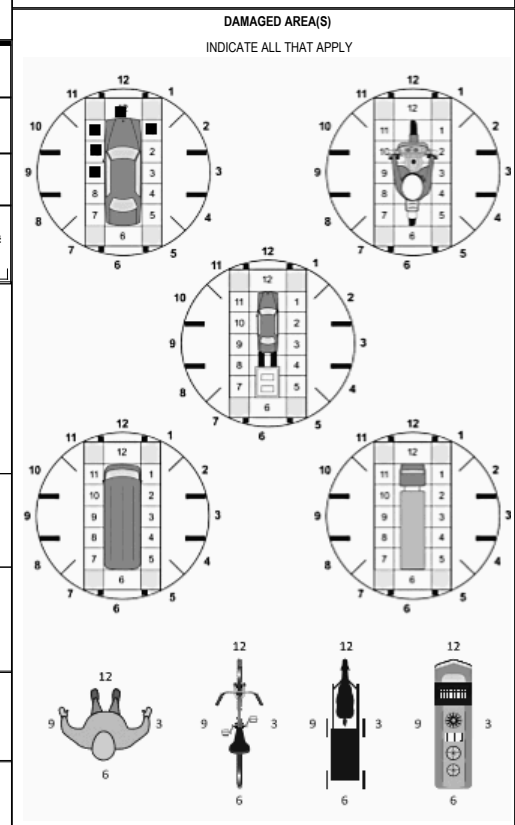
