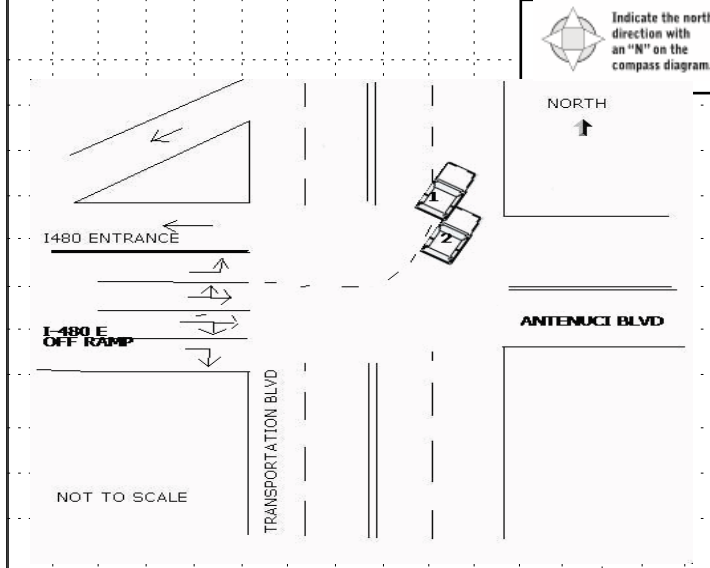

NARRATIVE
 UNITS 1 AND 2 WERE STOPPED ON THE I-480 EAST OFF RAMP AT TRANSPORTATION BLVD WAITING TO MAKE A LEFT TURN. UNIT 1 WAS IN THE FAR LEFT TURN LANE AND UNIT 2 WAS IN THE LEFT TURN LANE TO THE RIGHT OF UNIT 1. BOTH UNITS BEGAN TO MAKE THE LEFT TURN AND UNIT 1 DROVE INTO UNIT 2'S LANE AND SIDE SWIPED THE LEFT SIDE OF UNIT 2 WITH THE RIGHT REAR OF UNIT 1. BOTH DRIVERS CAME TO THE STATION SHORTLY AFTER CRASH TO FILE A REPORT. DRIVER OF UNIT 1 WAS UNAWARE THERE WERE TWO LEFT TURN LANES.

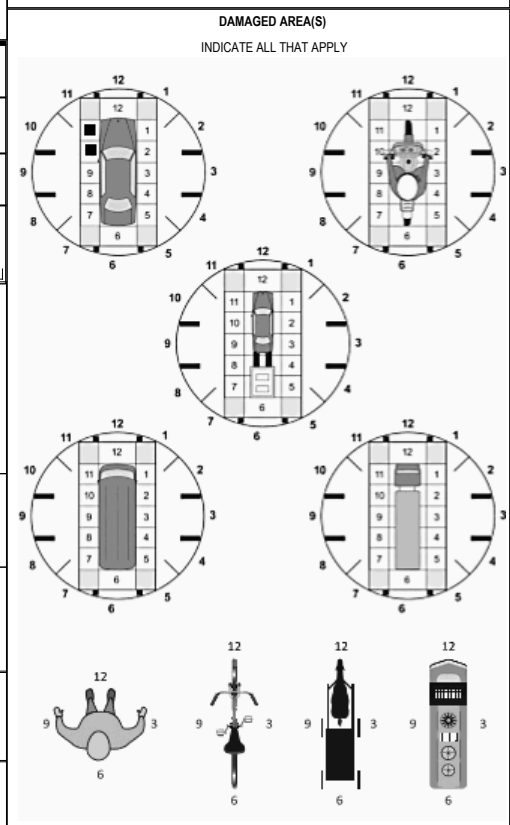

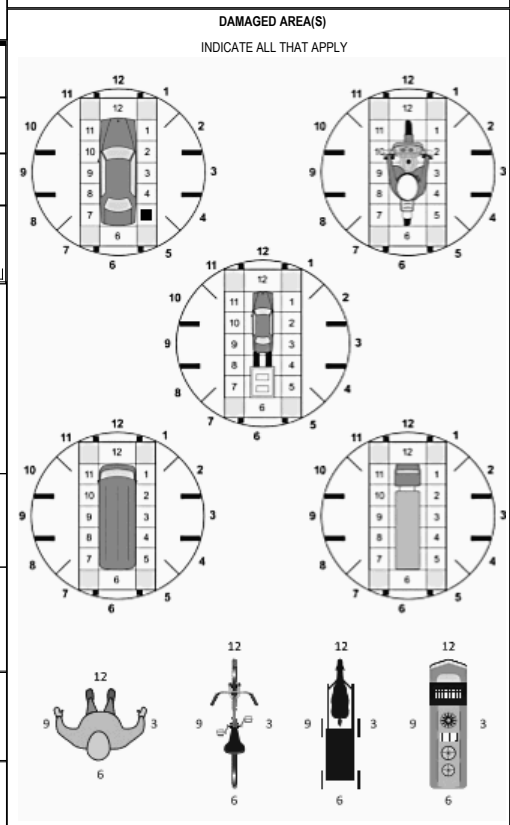
