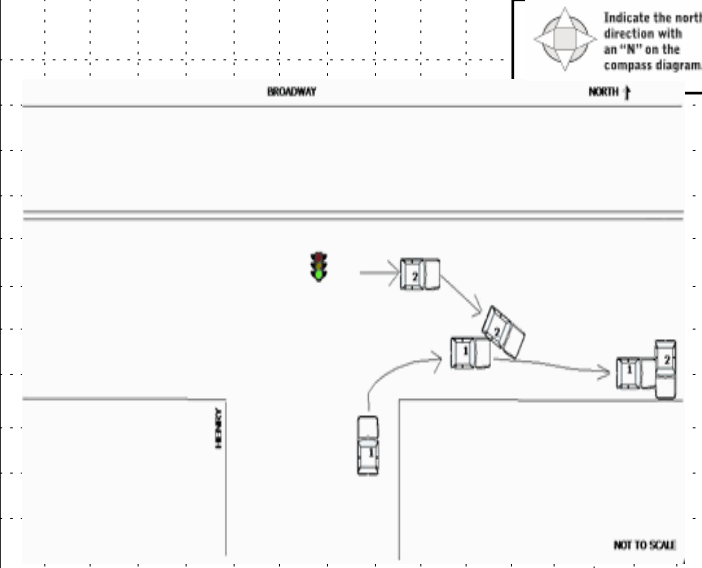

UNIT 1 STATED THAT AFTER TURNING RIGHT AND TRAVELING EAST ON BROADWAY, UNIT 2 CHANGED LANES AND CUT IN FRONT OF UNIT 1, CAUSING UNIT 1 TO IMPACT UNIT 2 IN THE RIGHT SIDE WITH THE FRONT LEFT OF UNIT 1.

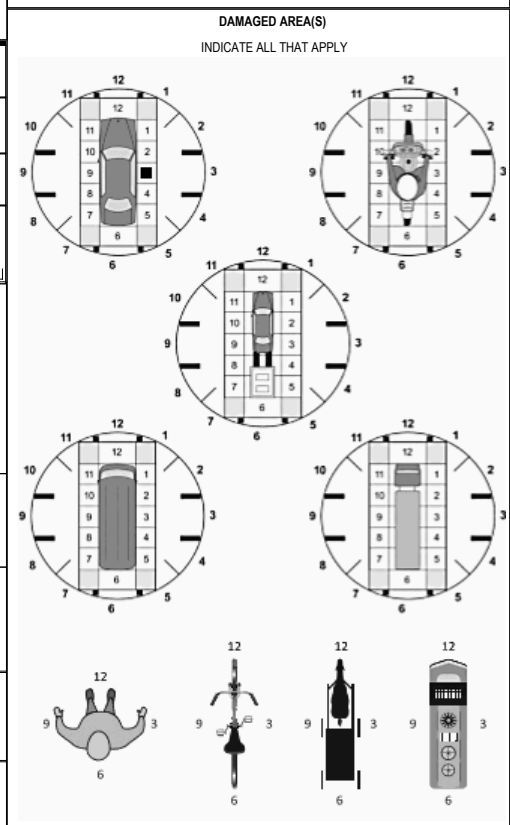
