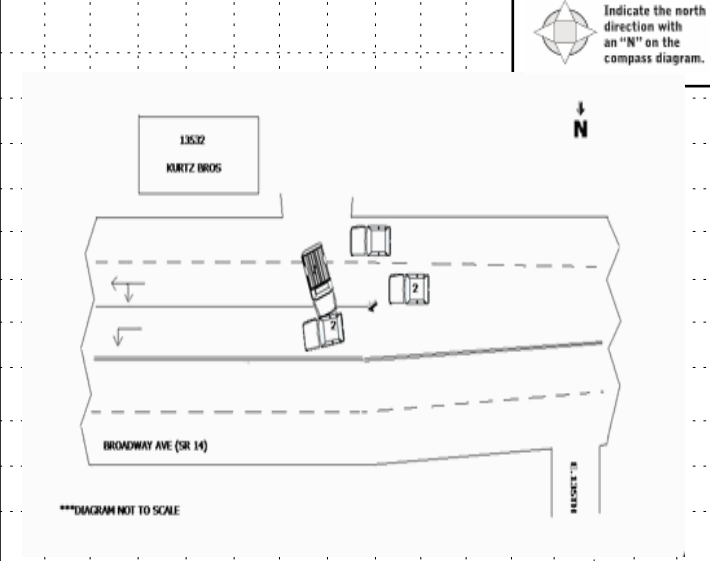

 UNIT 1 WAS EXITING THE LOT AT 13532 BROADWAY AVE (KURTZ BROS) WAITING TO MAKE A LEFT TURN. AN UNKNOWN VEHICLE STOPPED IN THE CURB LANE TO LET UNIT 1 OUT. UNIT 1 STARTED TO MAKE THE LEFT TURN AND FAILED TO YIELD TO UNIT 2, WHICH WAS TRAVELING E/B ON BROADWAY AVE IN CENTER LANE. UNIT 2 ATTEMPTED TO SWERVE TO THE LEFT TO AVOID THE CRASH, BUT UNIT 1 STRUCK UNIT 2 ON THE PASSENGER SIDE, CAUSING UNIT 2 TO SPIN 90 DEGREES.

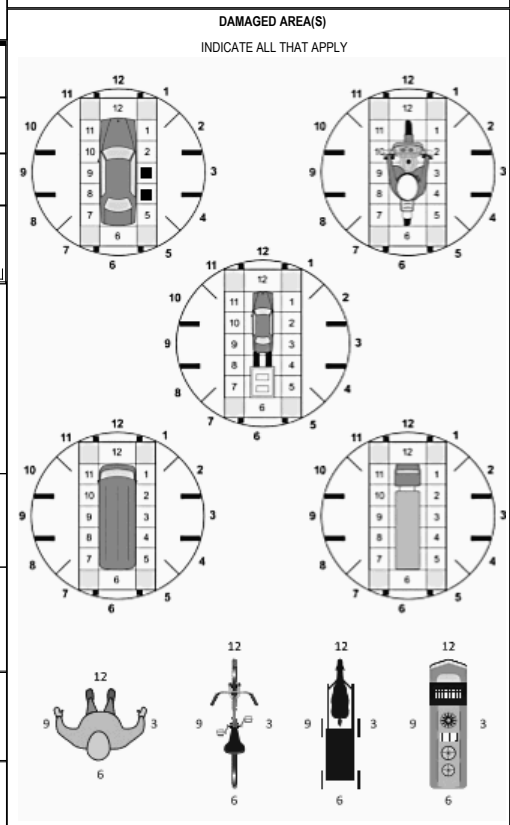
