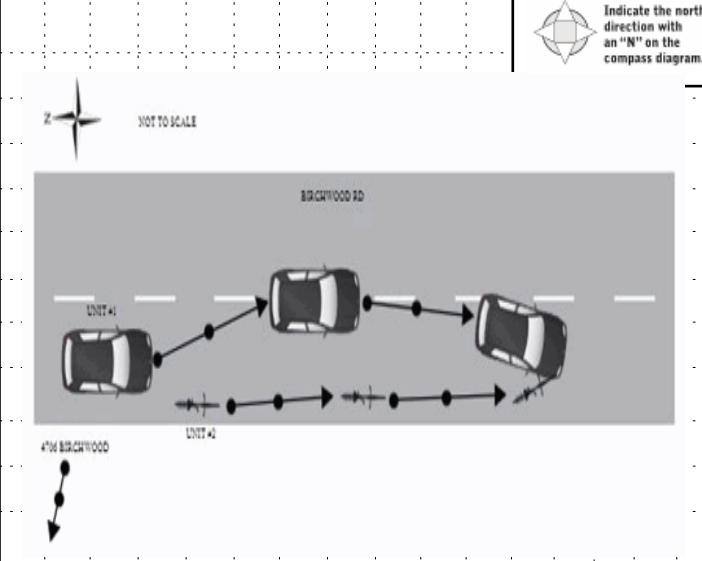

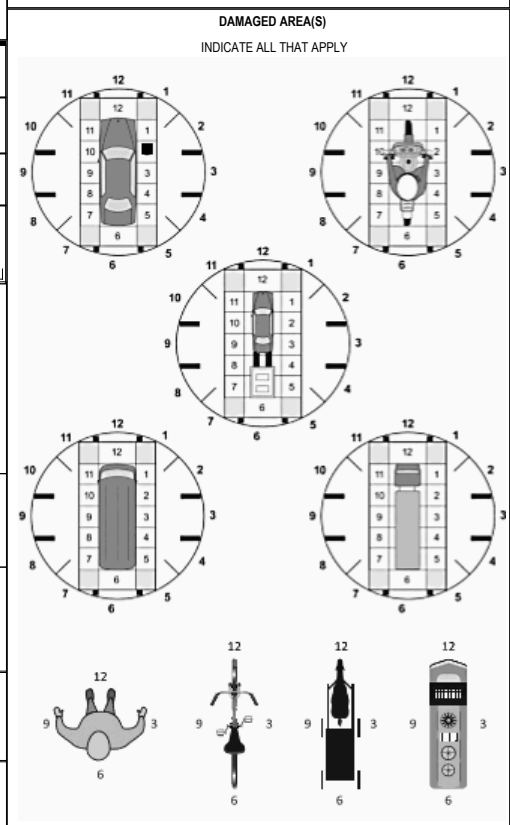

That witness stated it appeared as if Unit #1 struck unit #2 after swerving around Unit #2 and did so without enough clearance on the roadway, subsequently striking Unit #2.</p>
