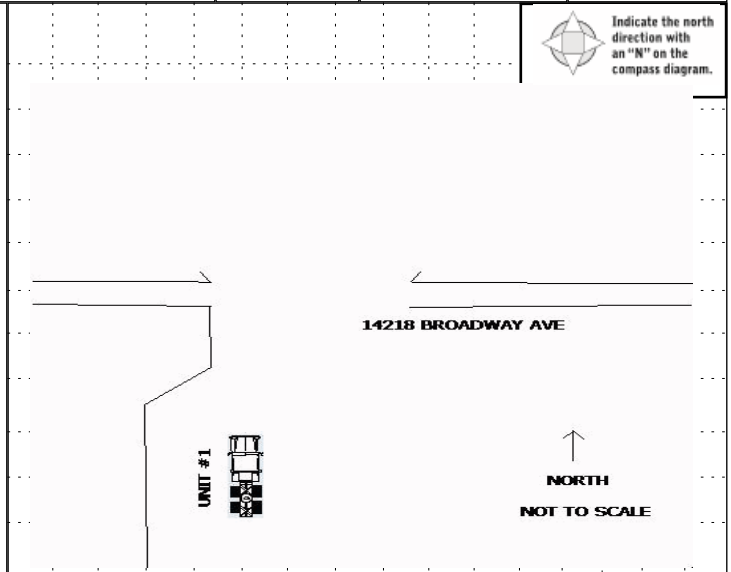

ON SEPTEMBER 5, 2019 AT ABOUT 1910 HOURS UNIT #1 WAS PARTIALLY EXITING THE BROADWAY MARATHON PARKING LOT WHEN UNIT #2 WAS BESIDE UNIT #1 AT THE SAME EXIT AND AS UNIT #1 BEGAN TO MOVE OUT OF THE PARKING LOT, UNIT #2 STRUCK UNIT #1. SHORTLY AFTER THE INCIDENT, UNIT #2 LEFT THE SCENE WITHOUT PROVIDING ANY INFORMATION. THE DRIVER OF UNIT #1 OBSERVED THE DRIVER OF UNIT #2 AND WOULD BE ABLE TO IDENTIFY HER.

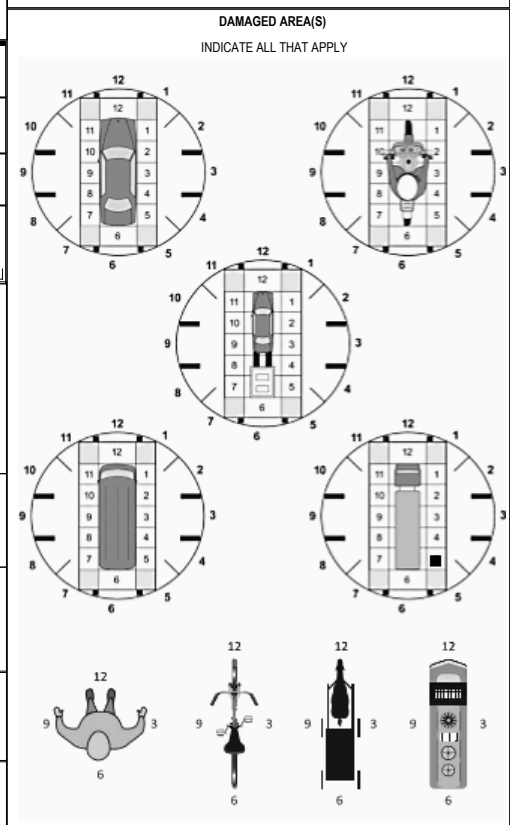
