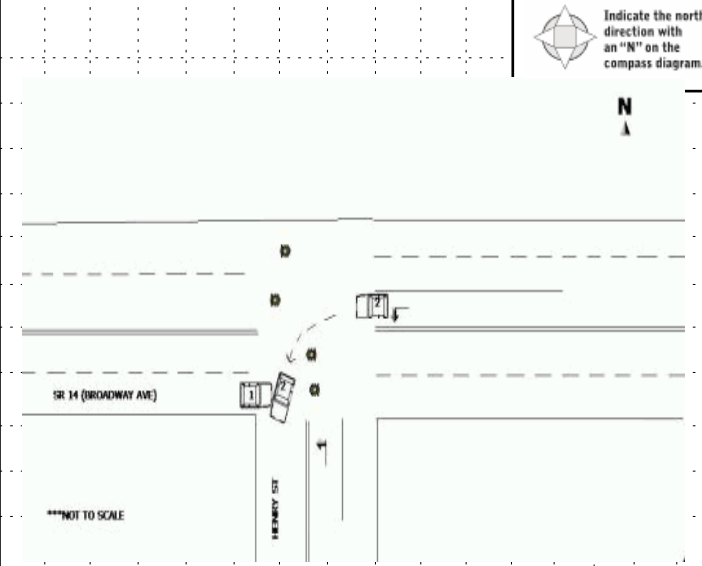

 DRIVER OF UNIT 1 STATED SHE WAS TRAVELING E/B ON BROADWAY AVE IN THE CURB LANE. AS SHE WAS AT THE HENRY ST. INTERSECTION THE TRAFFIC SIGNAL TURNED YELLOW AND SHE ATTEMPTED TO CONTINUE THROUGH INTERSECTION, WHEN UNIT 2 MADE A LEFT TURN IN FRONT OF HER. UNIT 1 THEN STRUCK THE PASSENGER SIDE OF UNIT 2. BOTH UNITS PULLED ONTO HENRY ST AND DRIVERS ARGUED FOR A COUPLE MINUTES THEN UNIT 2 FLED THE AREA. A LICENSE PLATE WAS NOT OBTAINED FOR UNIT 2. DRIVER OF UNIT 2 WAS DESCRIBED AS A LIGHT SKINNED BLACK FEMALE IN HER THIRTIES

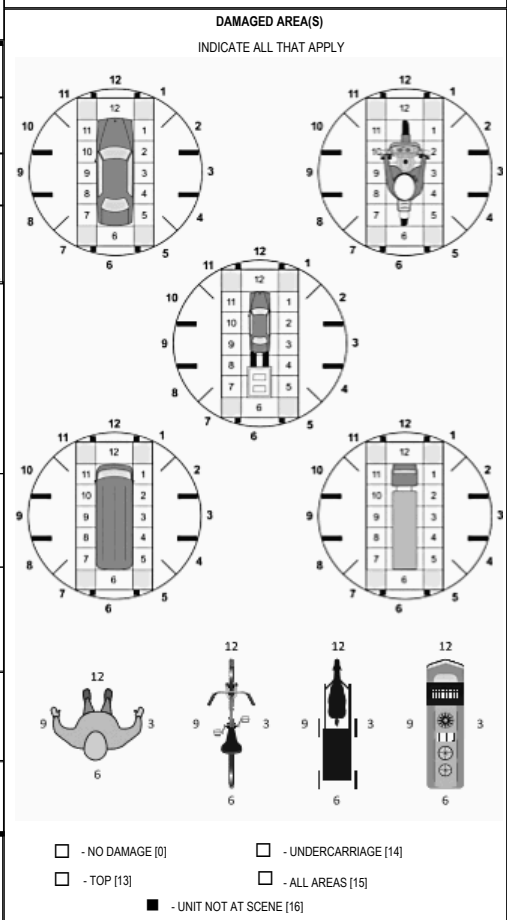
