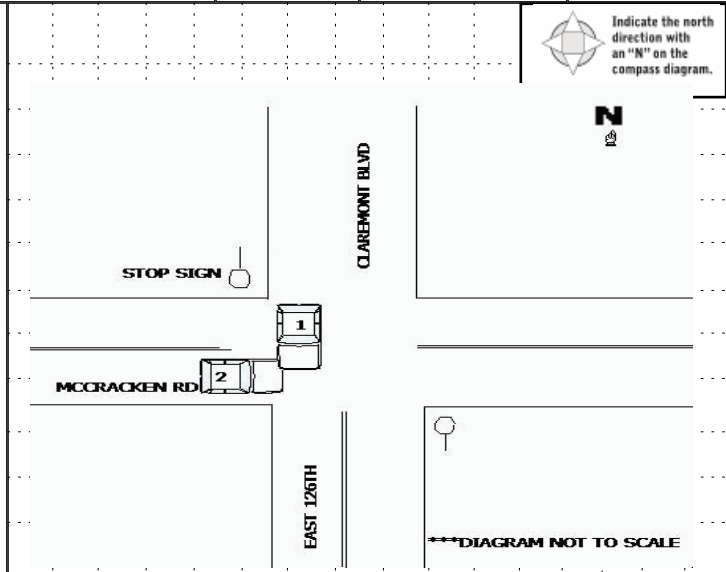

NARRATIVE

UNIT 1 WAS TRAVELING S/B ON CLAREMONT AND THEN STOPPED AT THE STOP SIGN AT MCCRACKEN RD INTERSECTION. UNIT 1 THEN PROCEEDED INTO THE INTERSECTION, IN AN ATTEMPT TO DRIVE STRAIGHT, AND FAILED TO YIELD TO UNIT 2, WHICH WAS TRAVELING E/B ON MCCRACKEN RD. UNIT 2 STRUCK THE RIGHT FRONT OF UNIT 1. UNIT 2 HAD NO TRAFFIC CONTROL DEVICE AND THEREFORE HAD NO DUTY TO YIELD AT INTERSECTION. DRIVER OF UNIT 2 COMPLAINED OF A POSSIBLE CHEST INJURY BUT REFUSED MEDICAL TREATMENT.

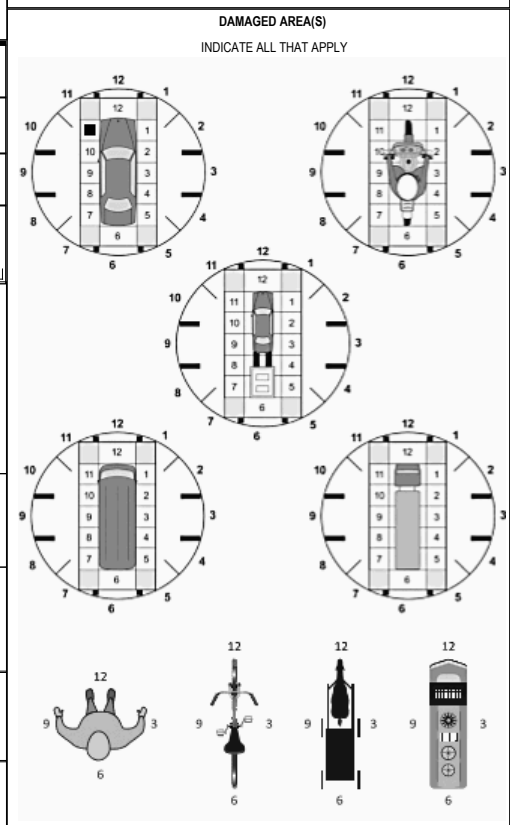

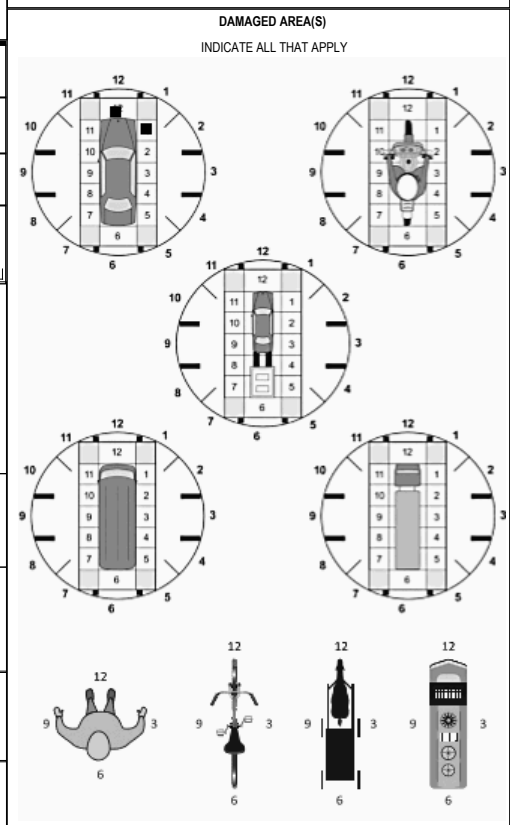
