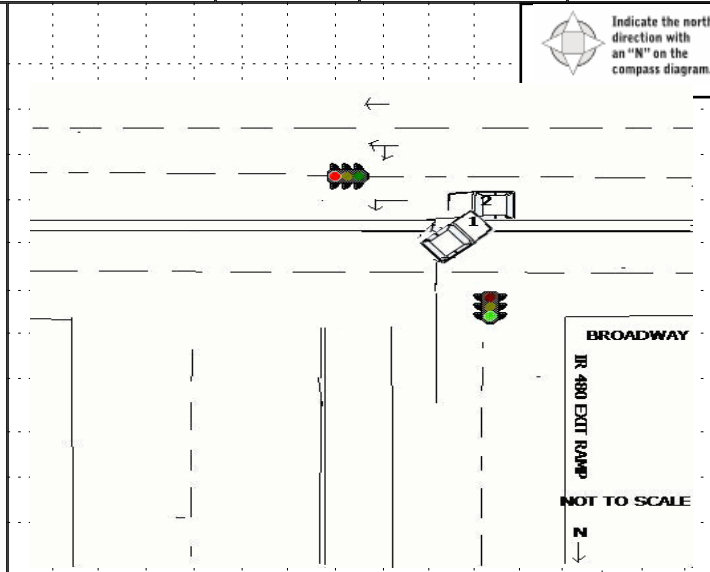

 UNIT #2 WAS STOPPED AT A RED LIGHT ON BROADWAY (E/B) PREPARING TO TURN LEFT ON TO 480. UNIT #1 STRUCK UNIT #2 AS IT WAS TURNING RIGHT ON TO BROADWAY. THE DRIVER OF UNIT #2 STATED UNIT #1 WAS TRAVELING AT A HIGH RATE OF SPEED AND TURNED AT THE LAST SECOND BEFORE STRIKING HIS VEHICLE. 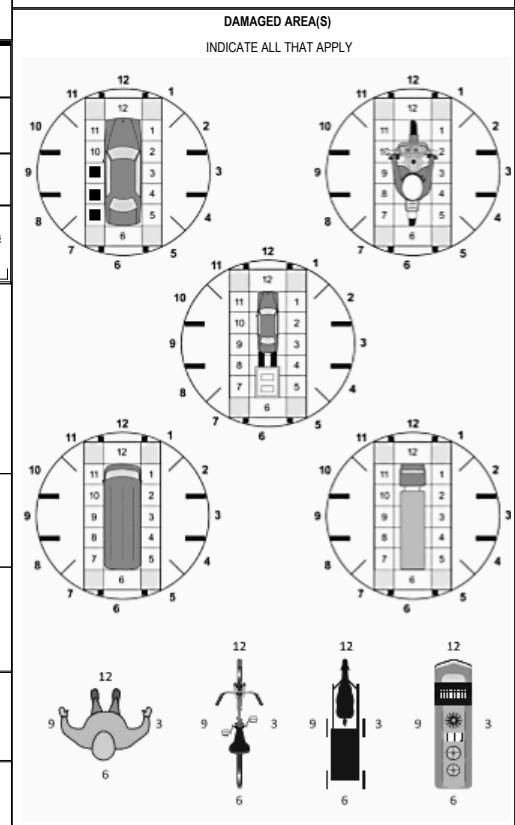

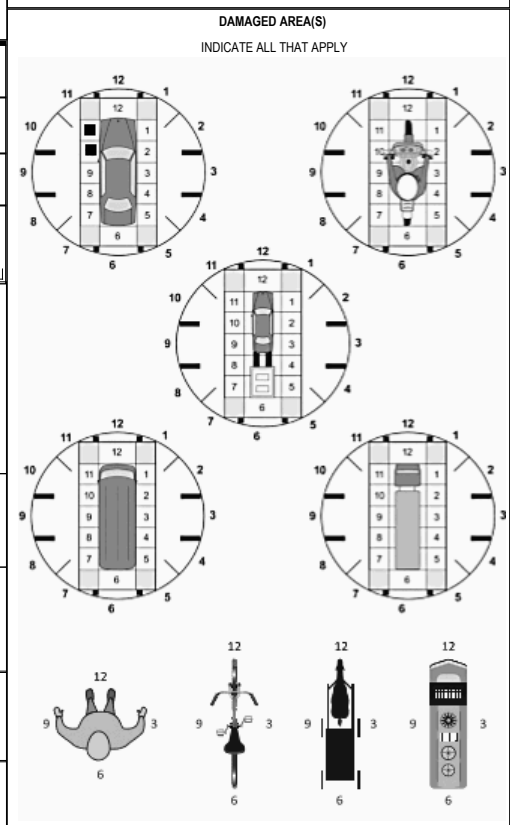
