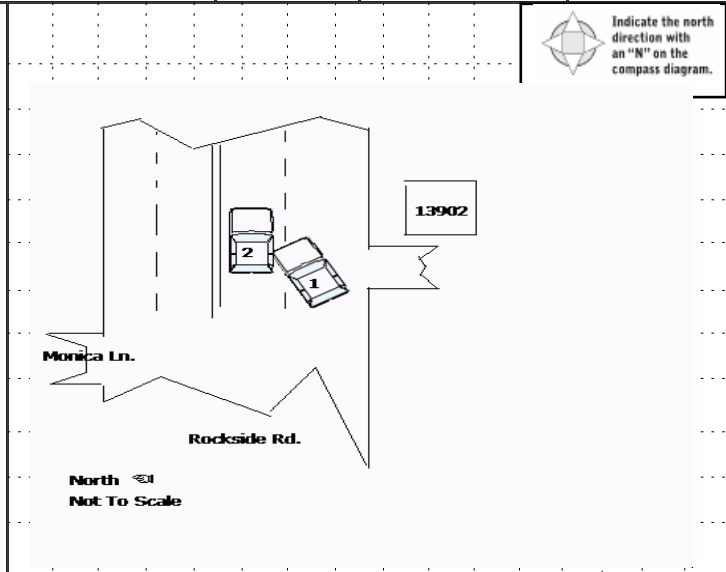

UNIT # 1 WAS STOPPED AT 13902 ROCKSIDE RD. IN THE OUTSIDE LANE FACING EAST. UNIT # 2 WAS TRAVELING EAST NEAR 13902 ROCKSIDE RD. IN THE INSIDE LANE. UNIT # 1 ATTEMPTED TO MAKE A U-TURN FROM A STOPPED POSITION. AS A RESULT, THE LEFT FRONT OF UNIT # 1 COLLIDED WITH THE LEFT REAR SIDE OF UNIT # 2. UNIT # 1 WAS PARKED FACING WEST ON ROCKSIDE NEAR MONICA LN. AND UNIT # 2 WAS PARKED FACING NORTH ON MONICA LN. BOTH UNITS WERE MOVED FROM FINAL REST.

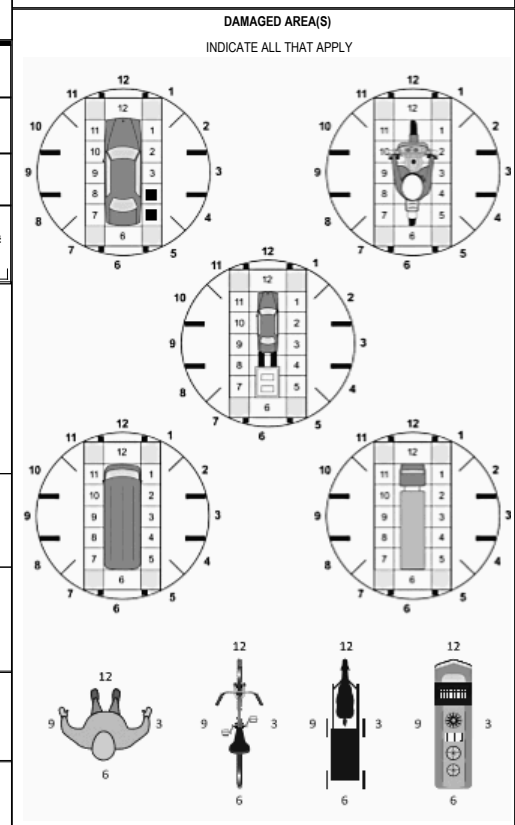

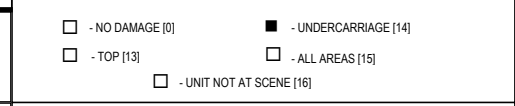
