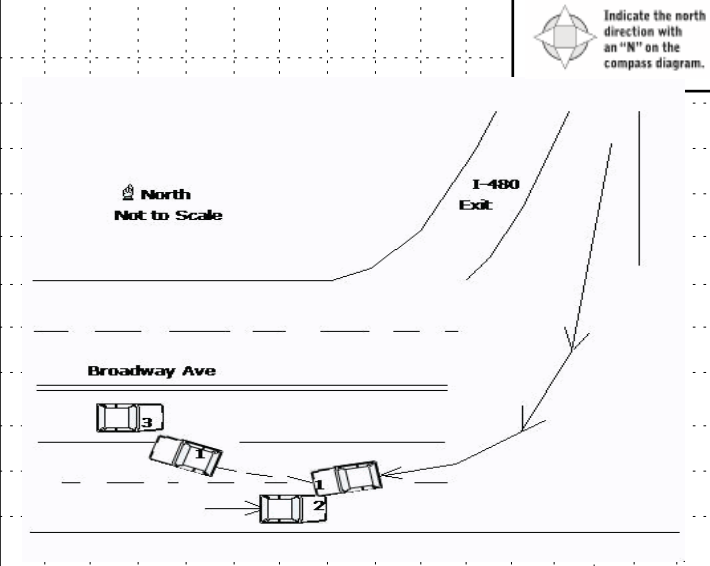

 UNIT 1 WAS TRAVELING ON THE I-480 EXIT TOWARD BROADWAY AVE. UNIT 2 WAS TRAVELING EAST ON BROADWAY AVE IN THE CURB LANE APPROACHING THE I-480 INTERSECTION. UNIT 3 WAS STOPPED IN TRAFFIC ON BROADWAY FACING EAST IN THE LEFT TURN LANE TO ENTER I-480. UNIT 1 WENT THROUGH A RED LIGHT LIGHT AT BROADWAY AND MADE A WIDE RIGHT TURN ONTO BROADWAY. UNIT 1 ENTERED THE EASTBOUND LANES AND STRUCK UNIT 2 IN THE CURB LANE AND THEN STRUCK UNIT 3 IN THE TURN LANE.

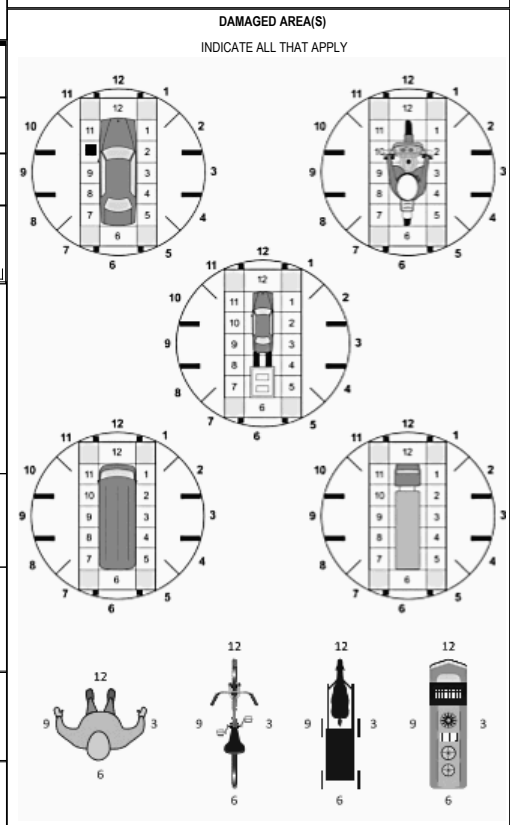
