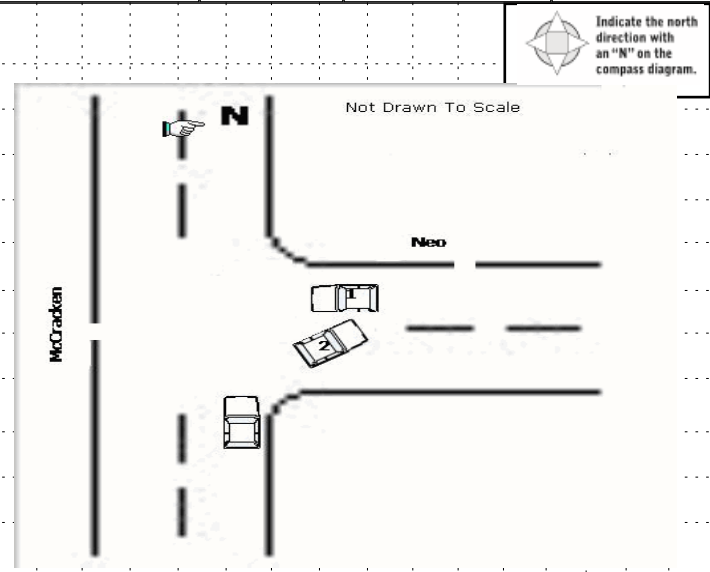

UNIT 1 STATES UNIT 2 WAS SLIDING TOWARDS HIS DRIVERS DOOR AND PULLED FORWARDED TO AVOID BEING STRUCK ON THE DOOR. AT THAT TIME UNIT 2 CONTINUED TO SLIDE A STRUCK UNIT 1 ON THE SIDE.

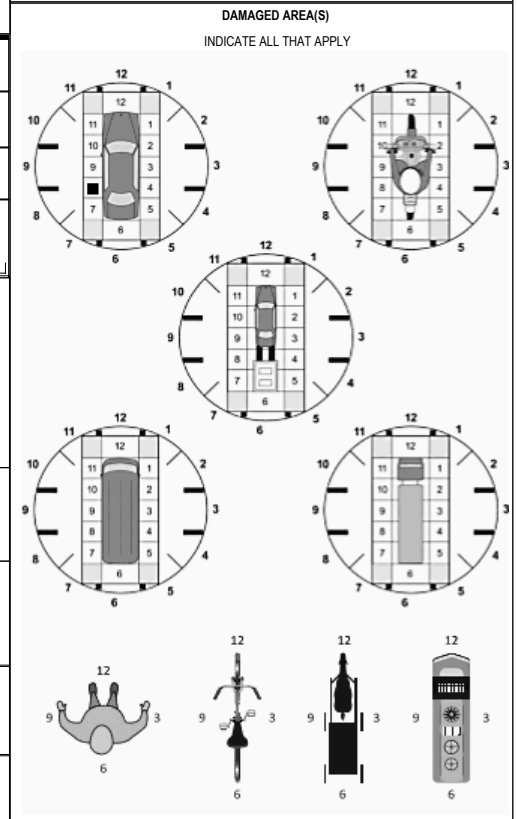
