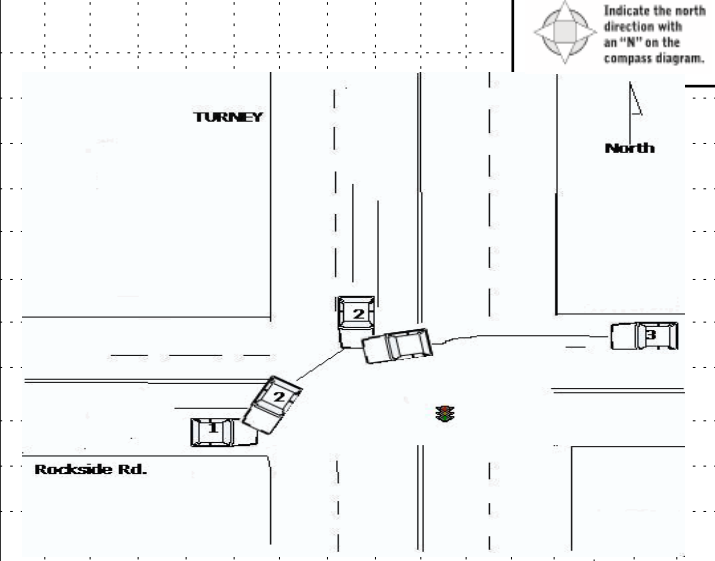

NARRATIVE: UNIT #2 STATED WHILE ATTEMPTING TO PROCEED S/B ON TURNEY RD, IT WAS STRUCK BY W/B UNIT #3 AFTER IT FAILED TO STOP AT THE RED LIGHT, WHICH CAUSED IT TO GO OFF THE RIGHT SIDE OF THE ROADWAY AND STRIKE UNIT #1, AS IT SAT AWAITING THE TRAFFIC SIGNAL. UNIT #3 STATED WHILE ATTEMPTING TO PROCEED THROUGH A STEADY GREEN TRAFFIC LIGHT, IT STRUCK UNIT #2 AFTER IT FAILED TO STOP FOR A POSSIBLE RED TRAFFIC LIGHT, WHICH CAUSED IT OFF THE RIGHT SIDE OF THE ROADWAY AND COLLIDED WITH E/B UNIT #1 AS IT SAT AWAITING THE TRAFFIC SIGNAL.

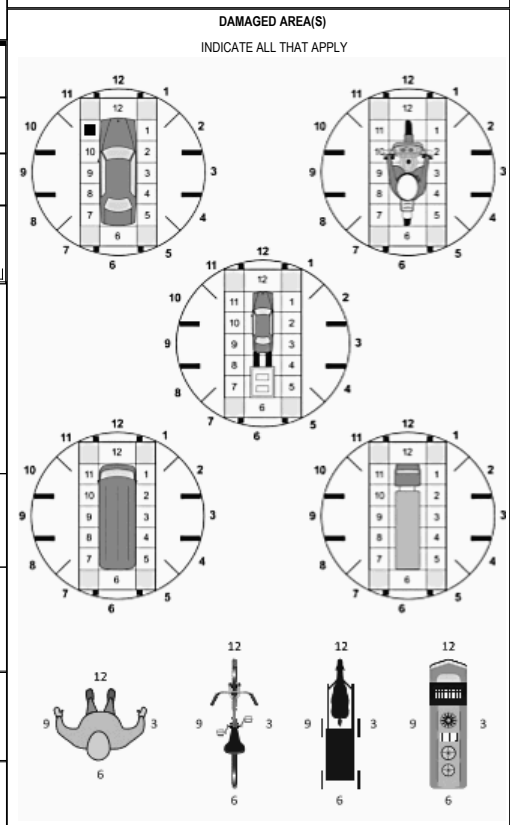

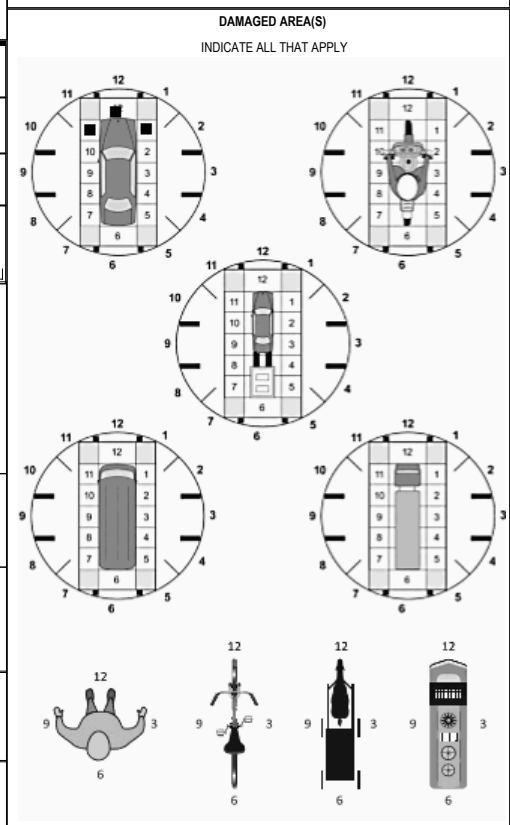

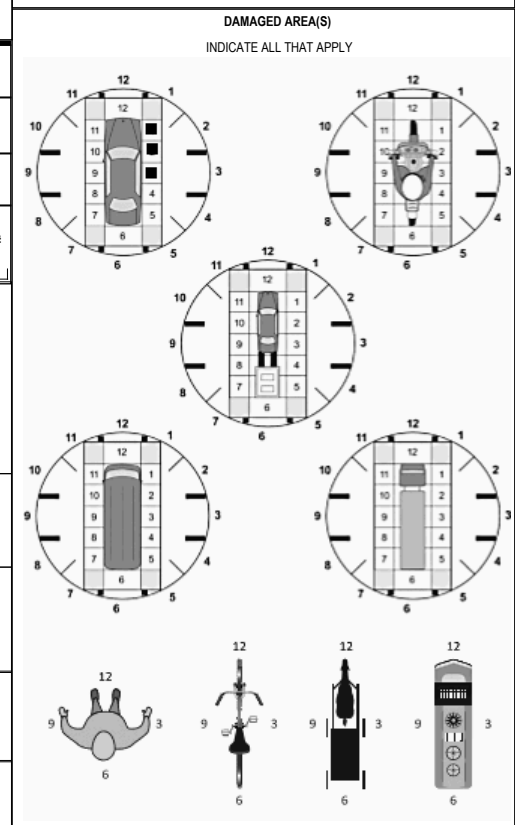
