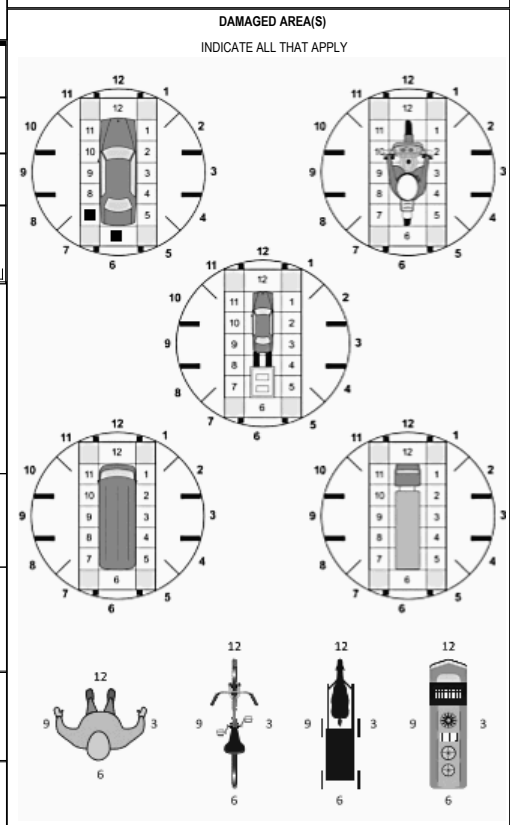

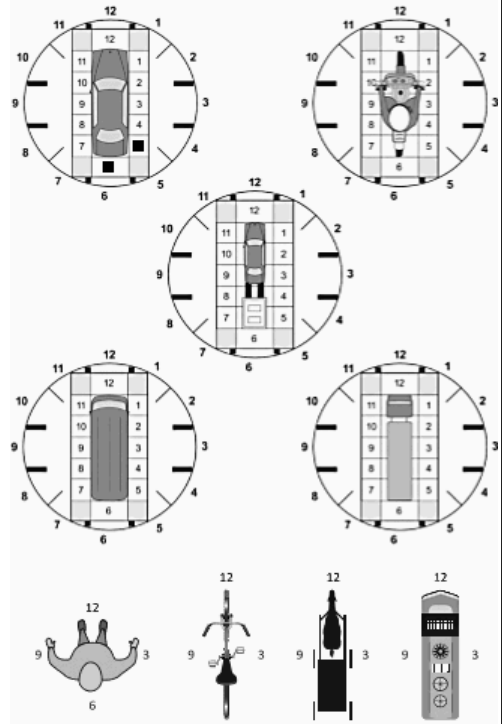

Officers observed multiple damaged areas on this vehicle, including damage to the rear of the vehicle consistent with the height of the impact of the damage to the victim's vehicles as well as rust on the bumper of the subject vehicle which was consistent with that discovered at the initial scene of the accident. The bumpers height was also consistent with the damage to the victims vehicles. Officers spoke with the vehicle owner, Emmanuel Johnson. Johnson was insistent that no one else drives his truck for any reason besides him. Johnson denied however, being involved with any MVA during the time this event occurred.
