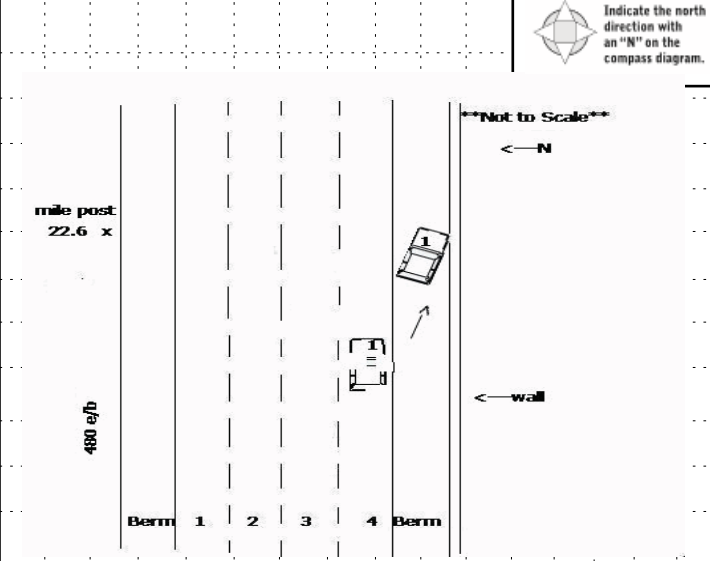

HIS VEHICLE WAS ABLE TO BE DRIVEN AWAY AFTER THE CRASH.

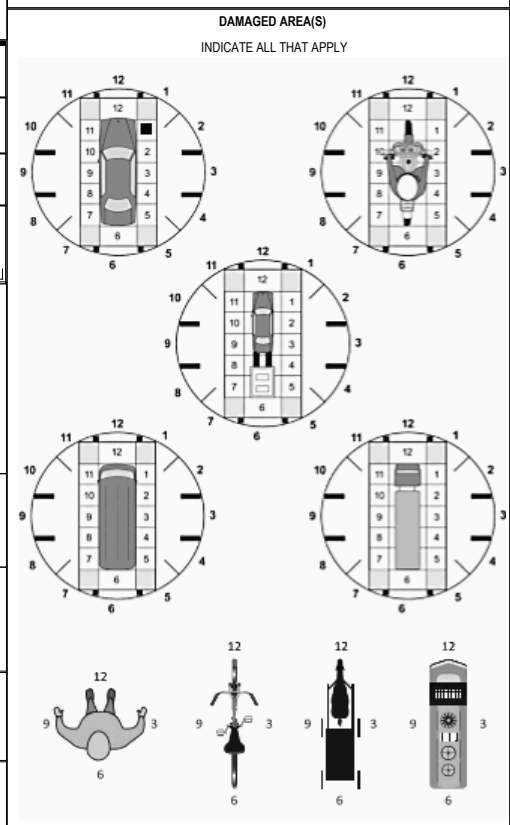
