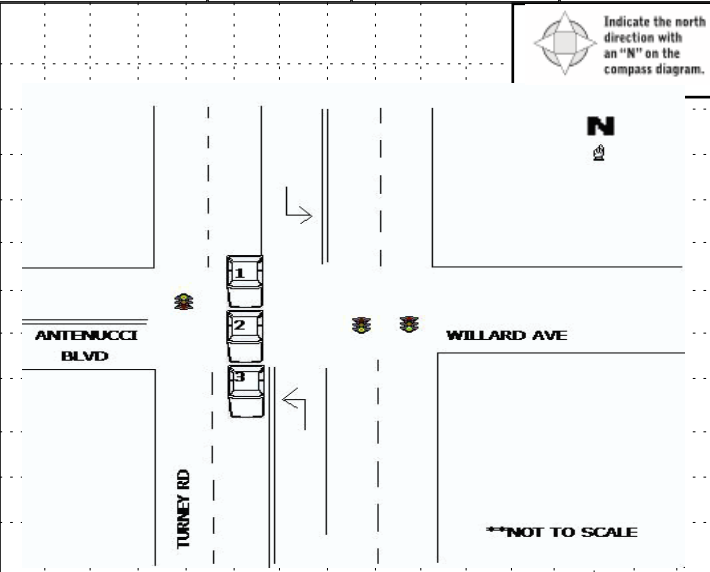

NARRATIVE
UNITS 1,2 AND 3 WERE TRAVELING S/B ON TURNEY RD IN THE LEFT LANE. UNIT 3 HAD TO STOP FOR TRAFFIC AS IT WAS TRAVELING THROUGH THE INTERSECTION AT ANTENUCCI BLVD AND UNIT 2 STOPPED BEHIND UNIT 3. UNIT 1 WAS TRAVELING BEHIND UNIT 2 AND FAILED TO STOP IN TIME AND STRUCK THE REAR OF UNIT 2. THAT CRASH CAUSED UNIT 2 TO ROLL FORWARD AND STRIKE THE REAR OF UNIT 3. UNIT 1 HAD TO BE TOWED FROM THE SCENE. OTHER UNITS WERE ABLE TO BE DRIVEN AWAY.

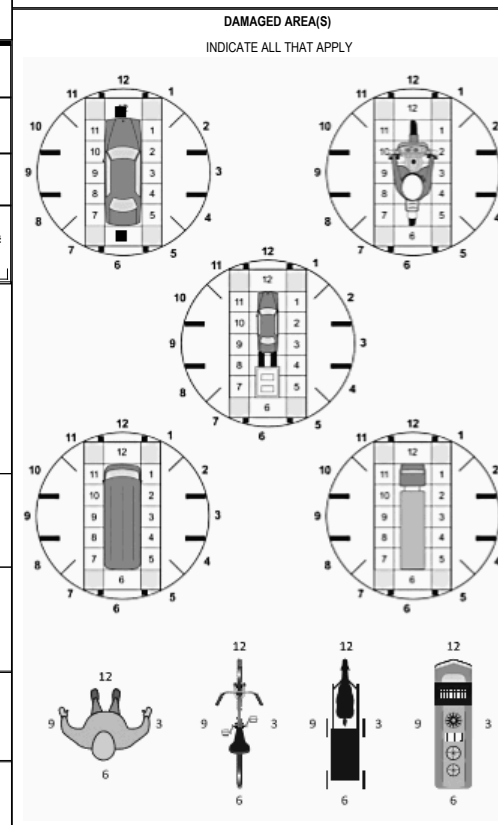

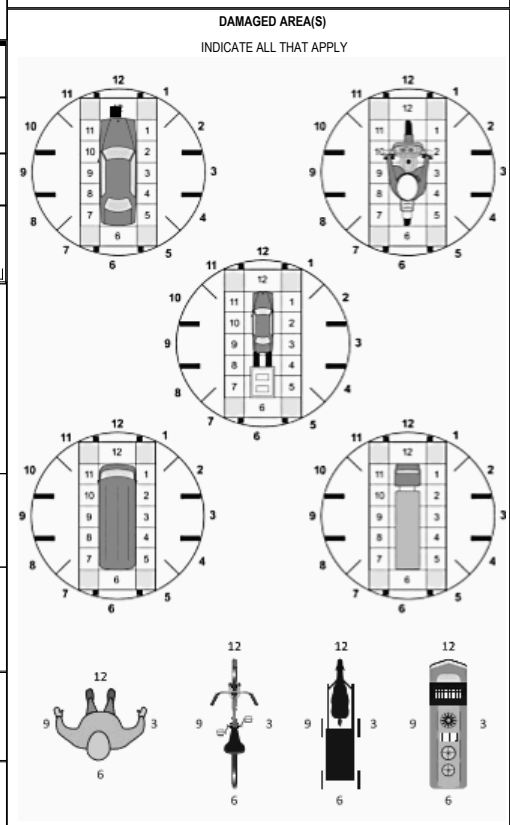

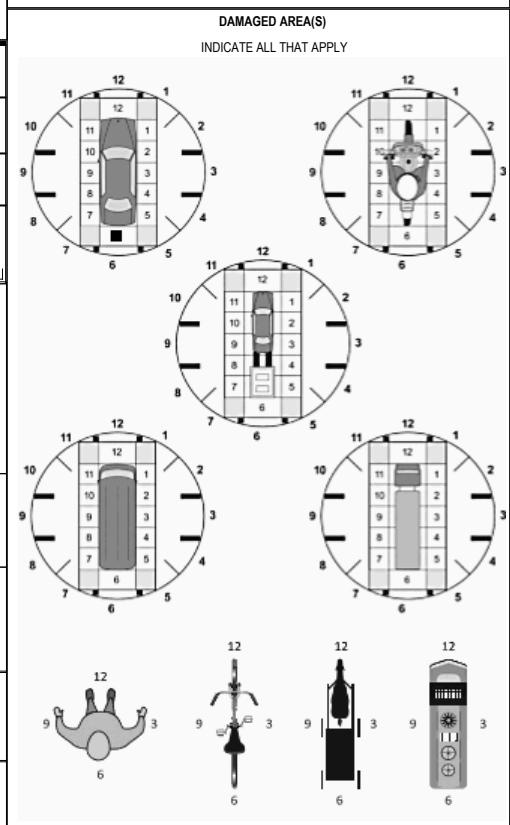
