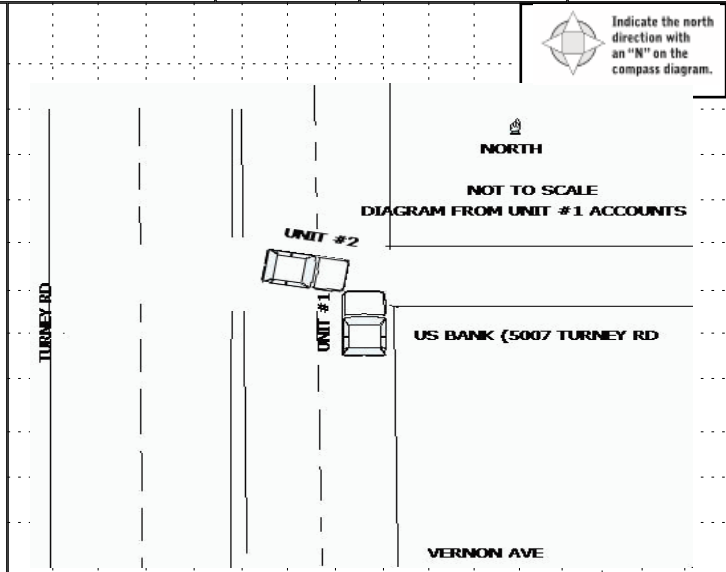

ON JANUARY 13, 2020 AT ABOUT 2100 HOURS UNIT # 1 WAS TRAVELING NORTH ON TURNEY RD. IN THE CURB LANE NEAR US BANK (5007 TURNEY RD.) WHEN UNIT #2 TURNED INTO U.S. BANK WITHOUT YIELDING TO UNIT #1 AND STRUCK UNIT #1 THEN FLED THE SCENE. ACCORDING TO THE OCCUPANTS OF UNIT #1, THE DRIVER OF UNIT #2 WAS A YOUNGER BLACK MALE IN HIS 20'S, BROWN SKIN, THIN BUILD, NO FACIAL HAIR, APPROXIMATELY 6 FEET TALL WITH A FLAT TOP HAIR CUT WITH DREADS.

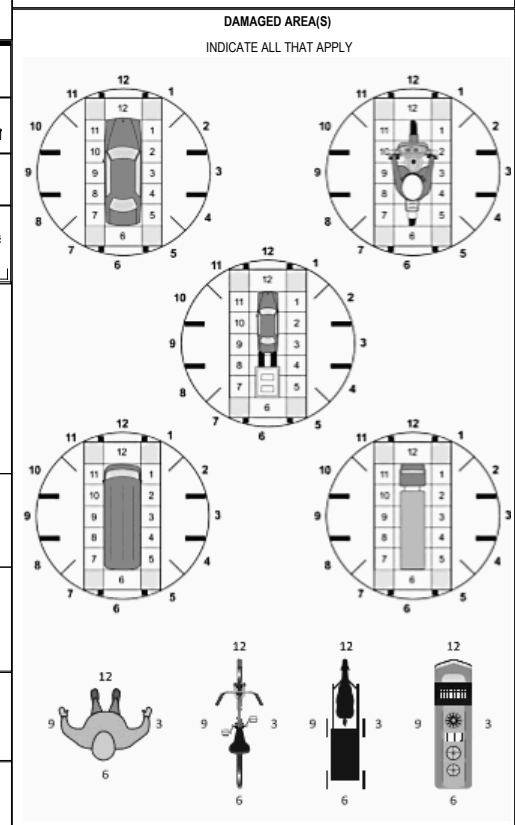

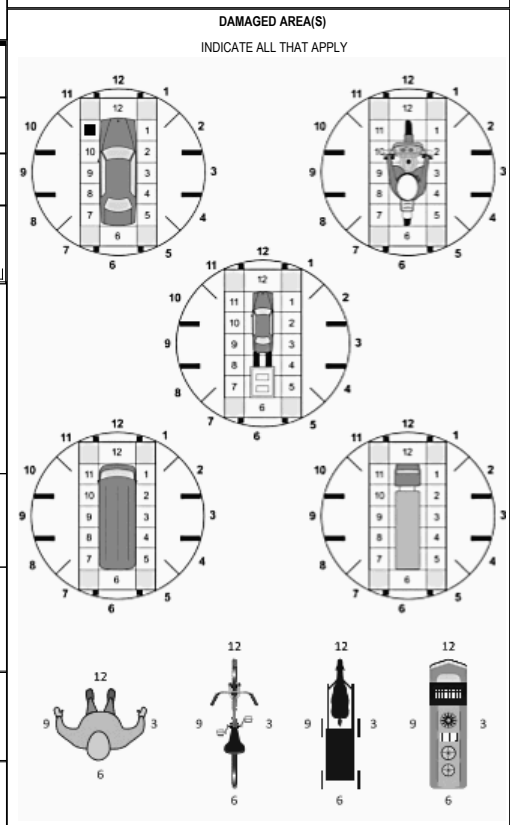
