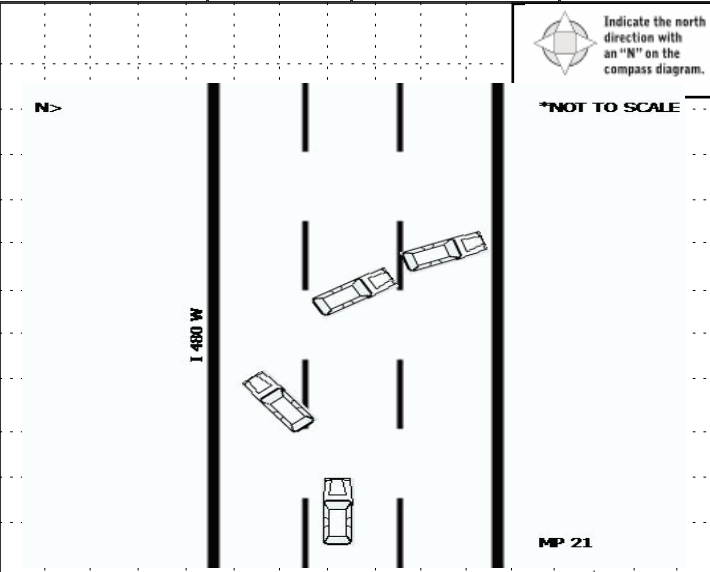

UNIT 1 WAS TRAVELING WEST ON I-480 AT MP 21 (TRANSPORTATION BLVD EXIT). UNIT 1 LOST CONTROL ON THE ICY ROADWAY AND WENT OFF ROAD LEFT. UNIT 1 OVER-CORRECTED AND RAN OFF ROAD RIGHT, SLIDING INTO THE BRIDGE EMBANKMENT UNDERNEATH TRANSPORTATION BLVD. (APPROX. 100YDS WEST OF MP21).
