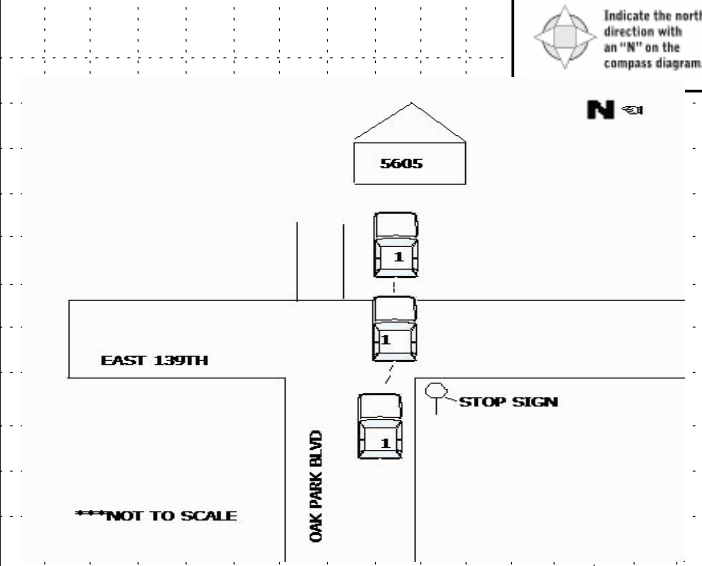

UNIT 1 WAS TRAVELING E/B ON OAK PARK BLVD AT A HIGH RATE OF SPEED. UNIT 1 RAN THE STOP SIGN AT EAST 139TH ST AND WAS UNABLE TO STOP AND STRUCK THE CURB AT 5605 EAST 139TH. UNIT 1 THEN DROVE OVER THE TREE LAWN AND CAME TO REST ON THE FRONT LAWN OF SAID ADDRESS. BOTH OCCUPANTS THEN FLED THE VEHICLE. THERE WAS POSSIBLE DAMAGE TO THE LAWN BUT WAS SNOW COVERED AT TIME OF CRASH.

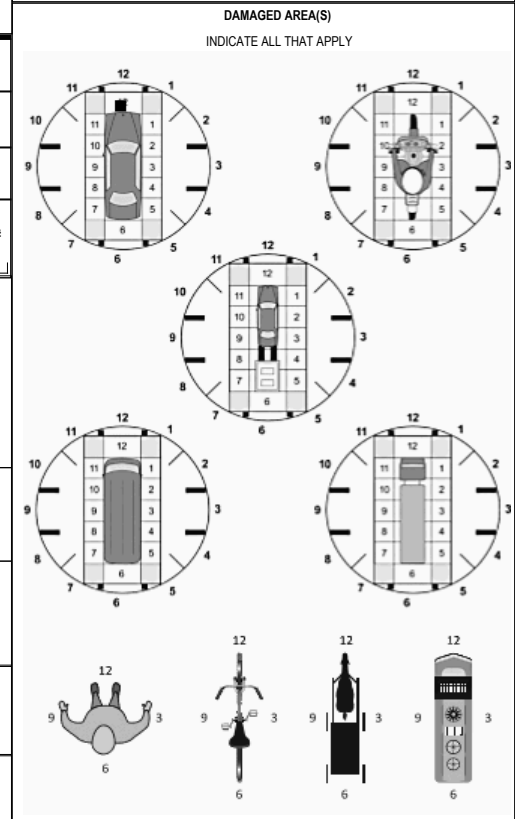

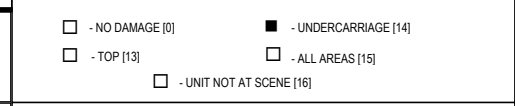
