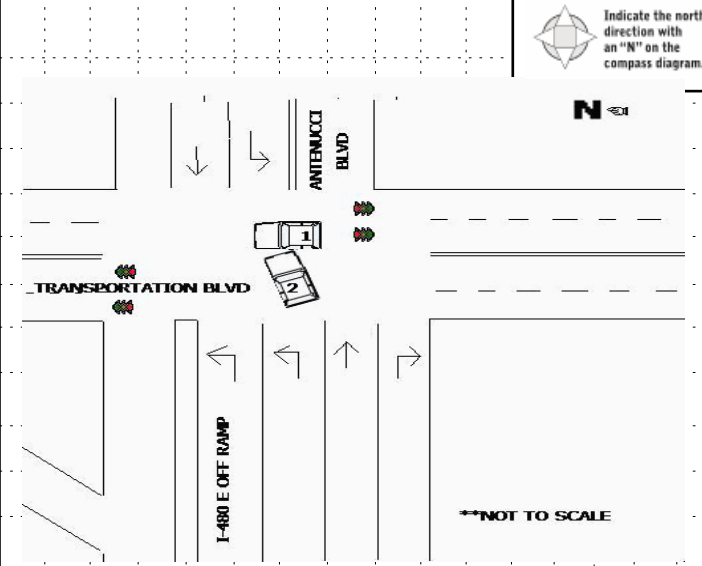

 UNIT 2 WAS TRAVELING ON THE I-480 EAST OFF RAMP AT TRANSPORTATION BLVD. UNIT 2 WAS IN THE LEFT TURN LANE (RIGHT ONE) AND OBSERVED A GREEN LEFT TURN SIGNAL. UNIT 2 DROVE INTO THE INTERSECTION AND STARTED TO MAKE THE LEFT TURN ONTO TRANSPORTATION BLVD. AS UNIT 2 WAS MAKING THE TURN, UNIT 2 WAS STRUCK BY UNIT 1, WHO RAN THE RED LIGHT N/B ON TRANSPORTATION BLVD. UNIT 1 WAS TRAVELING IN THE LEFT LANE. NO INJURIES WERE REPORTED.

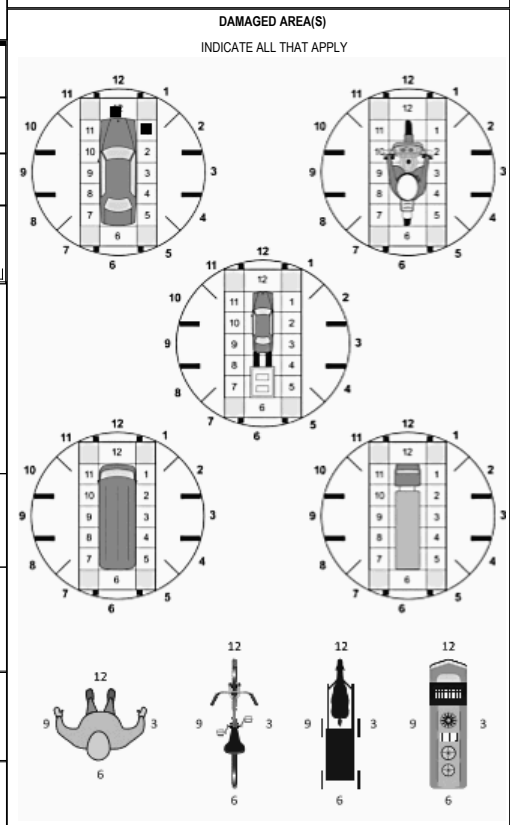

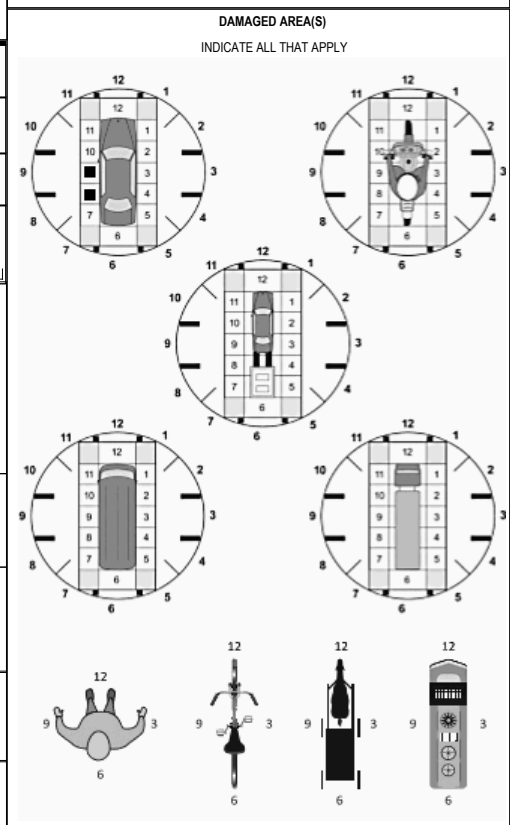
