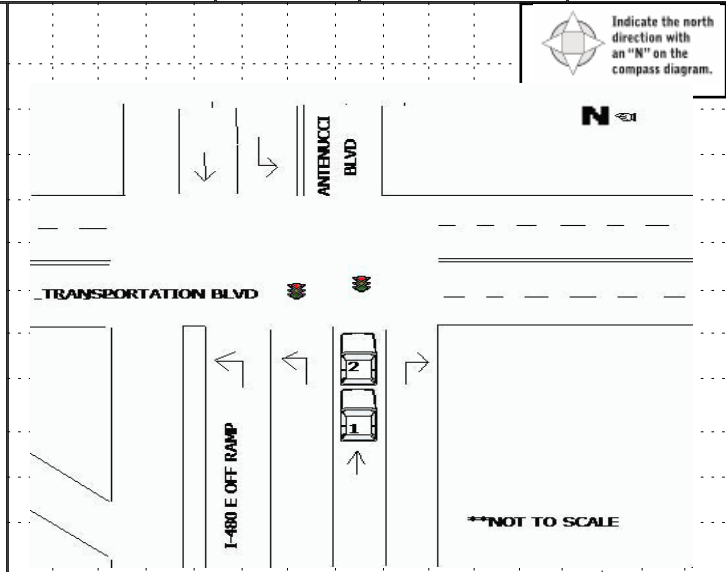

BOTH VEHICLES PULLED INTO ABOVE ADDRESS AFTER CRASH. DRIVER OF UNIT 1 STATED THERE WAS NO DAMAGE AND REFUSED TO GIVE ANY OTHER INFO AND LEFT THE SCENE PRIOR TO POLICE ARRIVAL. THIS OFFICER OBSERVED NO DAMAGE TO UNIT 2. DRIVER OF UNIT 2 COMPLAINED OF A POSSIBLE NECK INJURY.

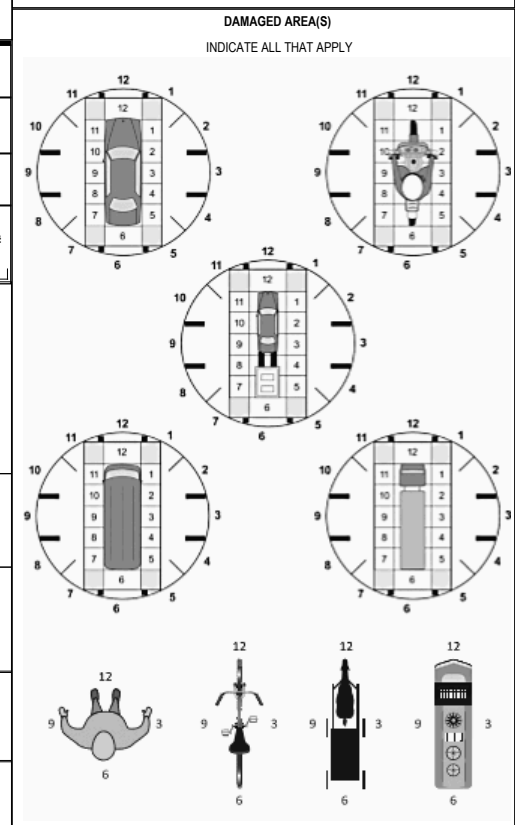
