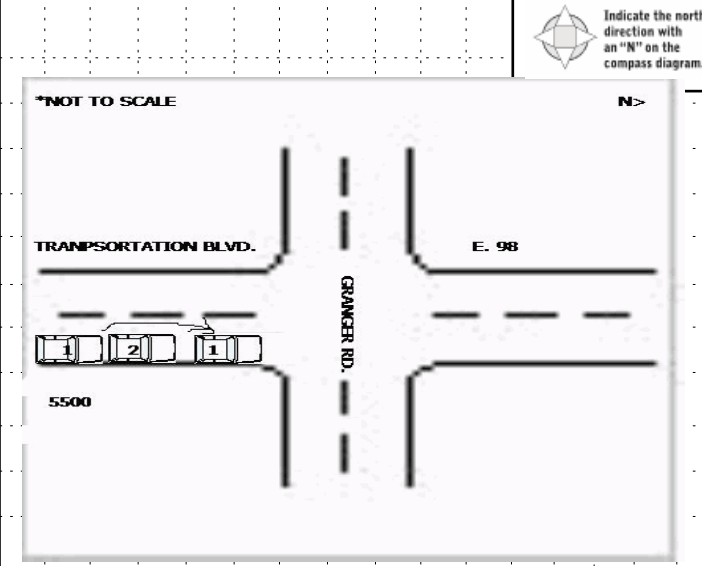

NARRATIVE
 UNIT 1 WAS TRAVELING NORTH ON TRANSPORTATION BLVD. APPROACHING 5500 (ODOT OFFICE). UNIT 2 WAS DISABLED ON THE SIDE OF THE ROAD AWAITING ROADSIDE ASSISTANCE. UNIT 1 FAILED TO NOTICE UNIT 2 AND DID NOT STOP, REAR ENDING UNIT 2. ACCORDING TO OCCUPANTS OF UNIT 2, UNIT 1 THEN ATTEMPTED TO FLEE THE SCENE BUT BECAME IMMOBILIZED ABOUT 500 FT NORTH OF THE CRASH. THE DRIVER OF UNIT 1 THEN EXITED THE VEHICLE, REMOVED HER INFANT PASSENGER AND WALKED AWAY NORTH ON TRANSPORTATION.

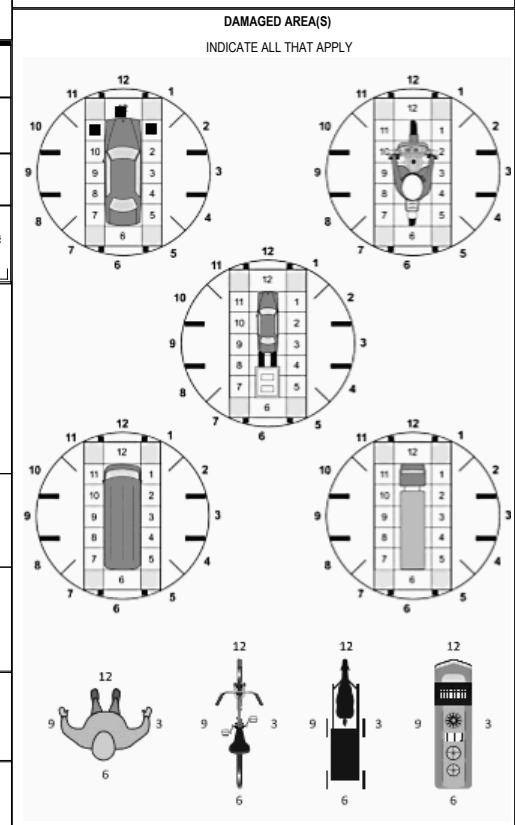

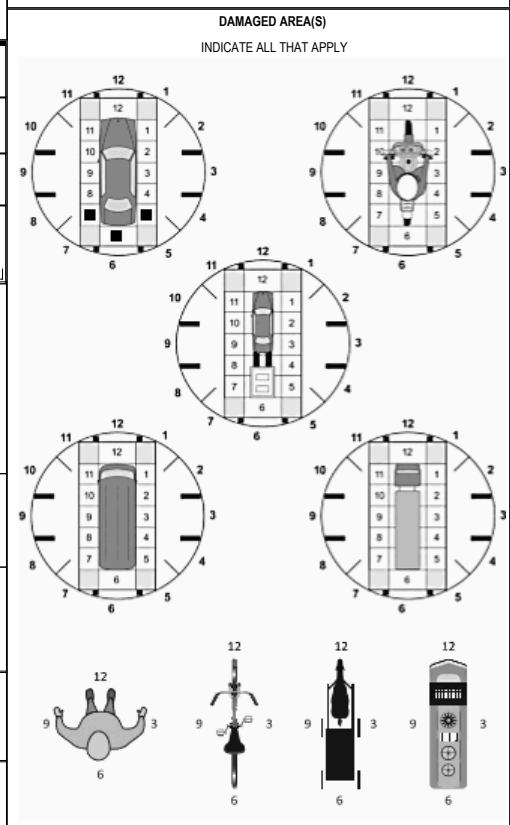
