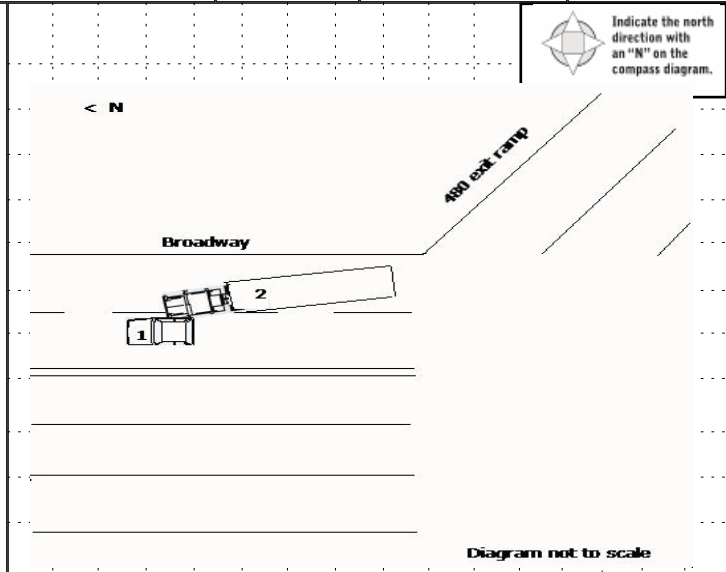

DRIVER OF UNIT 1 STATES HE WAS EXITING 480 ONTO BROADWAY AND UNIT 2 MADE A WIDE RIGHT TURN STRIKING UNIT 1. DRIVER OF UNIT 2 STATES HE BEGAN TO MAKE A RIGHT TURN FROM 480 OFF RAMP ONTO BROADWAY. HE LOOKED TO HIS LEFT TO CHECK FOR VEHICLES AND DID NOT SEE ANY. UNIT 2 THEN MADE A RIGHT TURN AND STATES UNIT 2 WAS IN ITS LANE OF TRAVEL. DRIVER STATES THAT HE OBSERVED IN HIS MIRROR UNIT 1 TURNING RIGHT AT WHAT HE BELIEVED TO BE A HIGH RATE OF SPEED THEN STRUCK UNIT 2.

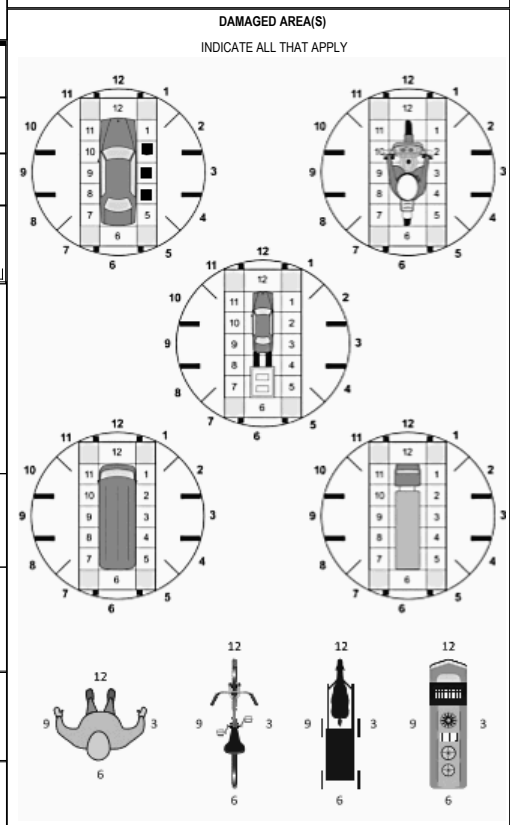

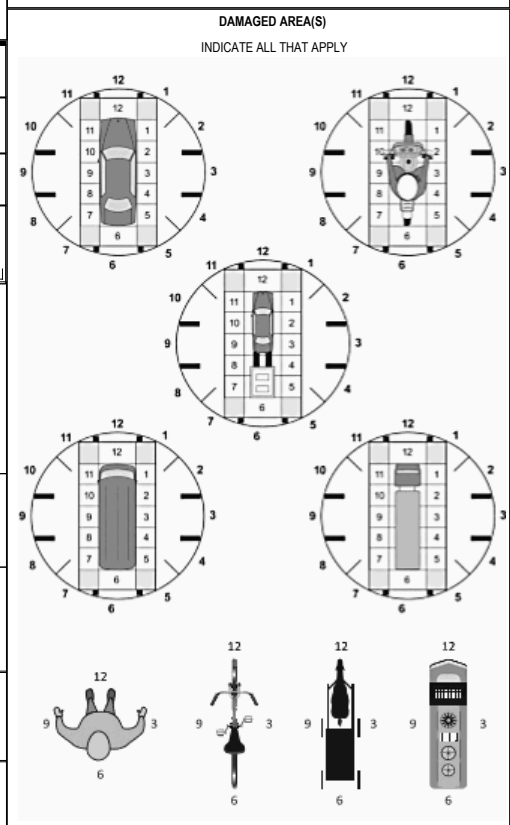
