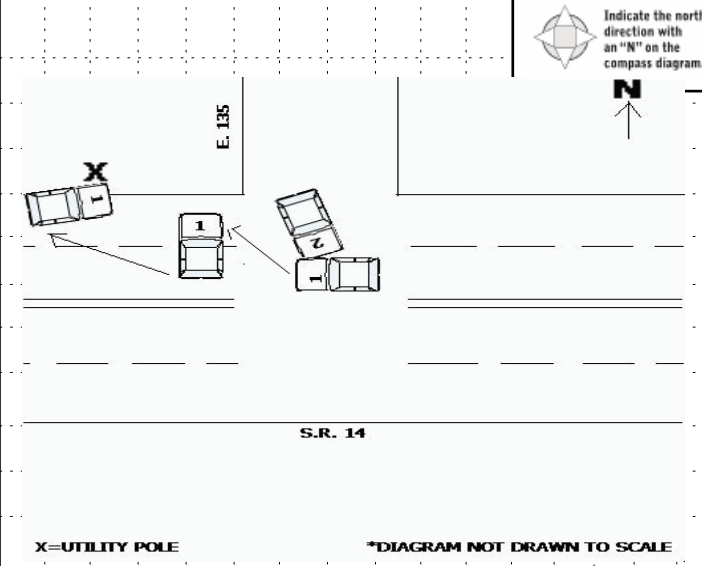

 UNIT 1 WAS TRAVELING IN THE LEFT LANE OF W/B SR 14 APPROACHING THE INTERSECTION WITH E. 135. UNIT 2 WAS STOPPED FOR THE STOP SIGN ON S/B E. 135 AT SR 14. UNIT 2 PROCEEDED TO PULL INTO THE INTERSECTION TO COMPLETE A LEFT TURN ONTO E/B SR 14. UNIT 2 FAILED TO YIELD TO UNIT 1 CAUSING UNIT 2 TO STRIKE UNIT 1 IN THE RIGHT FRONT. THE IMPACT FROM UNIT 2 CAUSED UNIT 1 TO SPIN AROUND AND TRAVEL OFF OF THE ROADWAY TO THE RIGHT AND STRIKE A UTILITY POLE. UTILITY POLE #54426 IS OWNED BY FIRST ENERGY CORP..

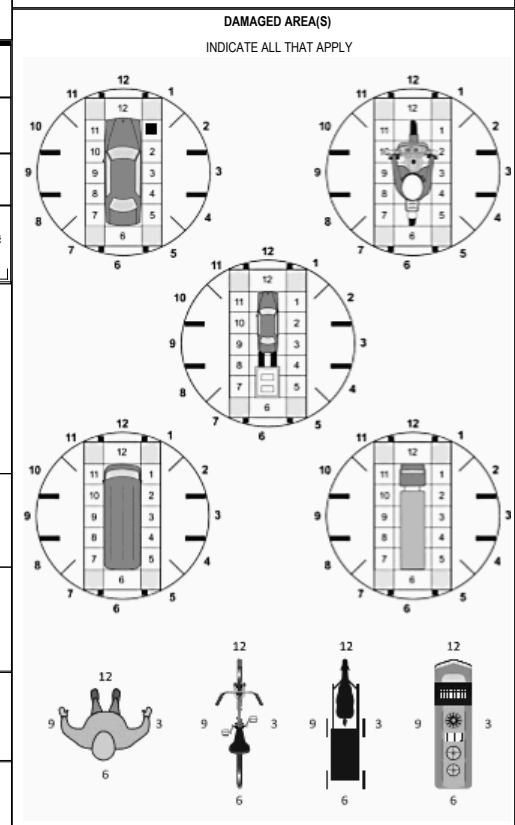

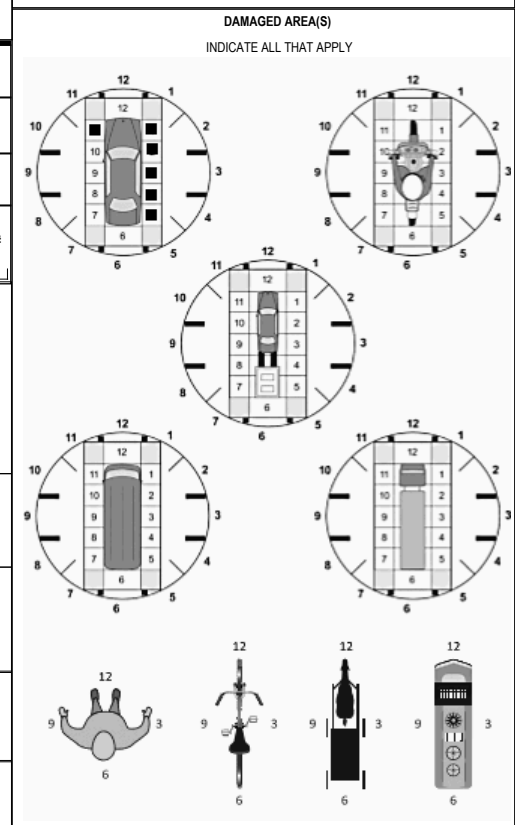
