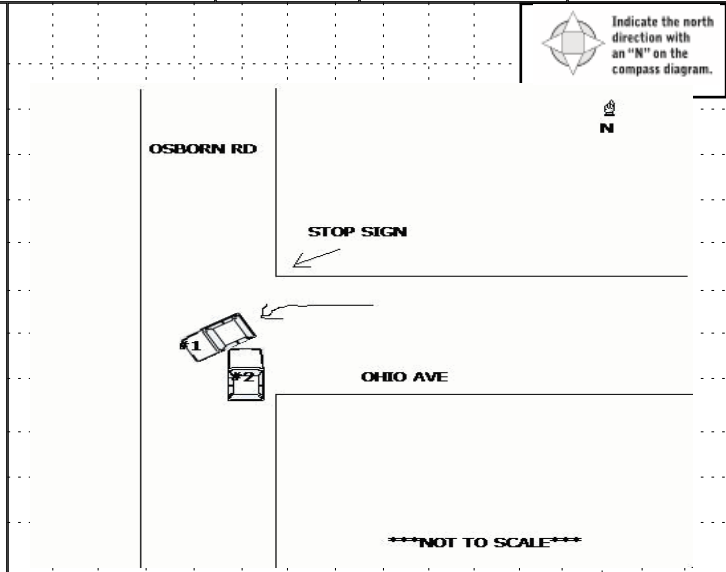

UNIT #1 WAS W/B ON OHIO AVE. AND STOPPED FOR THE STOP SIGN AT OSBORN RD. DRIVER OF UNIT #1 STATED THAT HE THOUGHT OSBORN RD. HAD STOP SIGNS AND PROCEEDED TO TURN LEFT (SOUTHBOUND) ONTO OSBORN RD, IN FRONT OF UNIT #2, AND WAS STRUCK BY UNIT #2 (HIT SKIP VEHICLE).

UNIT #2 WAS N/B ON OSBORN RD. AND STRUCK UNIT #1 WHEN UNIT #1 TURNED LEFT IN FRONT OF UNIT #2 FROM OHIO AVE. UNIT #2 QUICKLY LEFT THE SCENE WITHOUT EXITING THE VEHICLE OR EXCHANGING INFORMATION.
