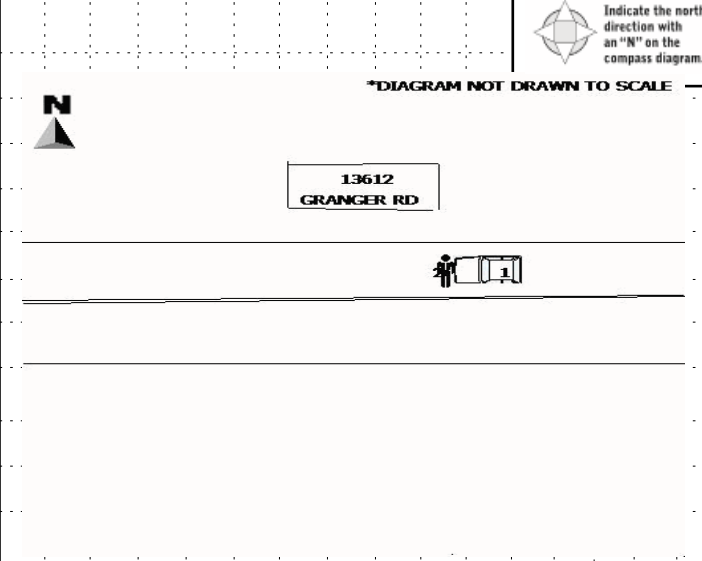

 UNIT 1 WAS TRAVELING WESTBOUND ON GRANGER IN THE AREA OF 13612 WHEN A JUVENILE MALE RAN INTO THE ROADWAY AND THE DRIVER OF UNIT 1 APPLIED HER BRAKES BUT WAS UNABLE TO AVOID STRIKING THE PEDESTRIAN. THE JUVENILE MALE PEDESTRIAN STATED HE WAS WALKING ON THE NORTH SIDE OF GRANGER RD WHEN A DOG RAN OUT OF A UNKNOWN YARD IN THE AREA OF 13612 AND STARTED TO CHASE HIM CAUSING THE MALE TO RUN SOUTH ACROSS GRANGER WHERE HE WAS STRUCK BY UNIT 1.
