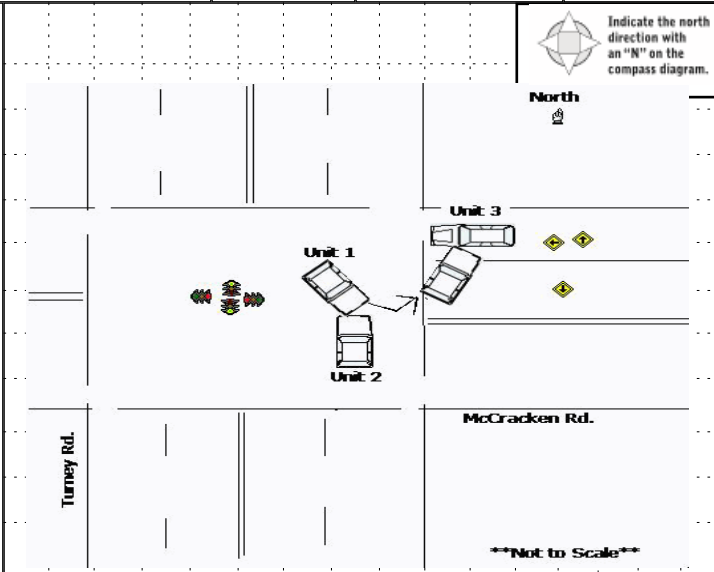

AS UNIT 1 WAS TURNING LEFT THROUGH THE INTERSECTION, UNIT 2 WAS TRAVELING NORTHBOUND ON TURNEY RD AND ENTERED THE INTERSECTION. UNIT 1 HAD FAILED TO YIELD TO ONCOMING TRAFFIC

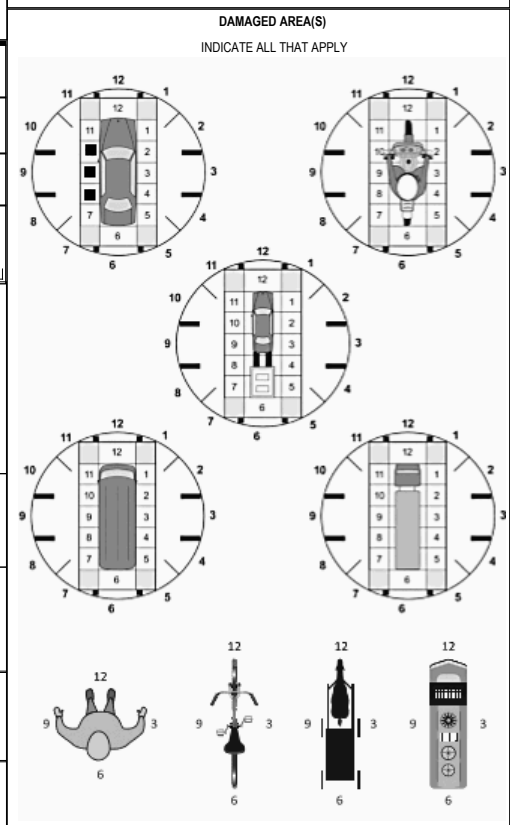
