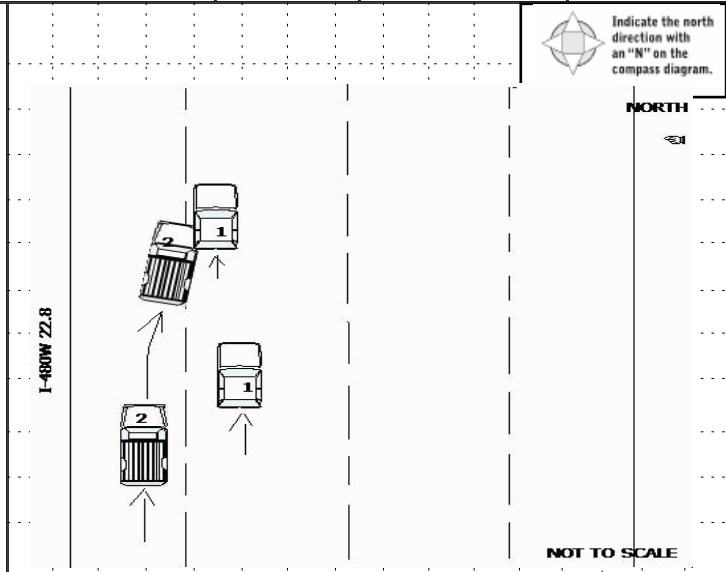

UNIT 1 WAS TRAVELING WEST ON I480 IN LANE 2 AT MP 22.8. UNIT 2 WAS TRAVELING IN LANE 1 NEXT TO UNIT 2 AND MADE AN IMPROPER LANE CHANGE STRIKING UNIT 1 IN THE LEFT REAR WITH THE RIGHT FRONT OF UNIT 2. OPERATOR OF UNIT 2 STATED THAT DUE TO SNOW AND POOR ROAD CONDITIONS HE WAS UNABLE TO JUDGE WHERE THE LANES WERE.

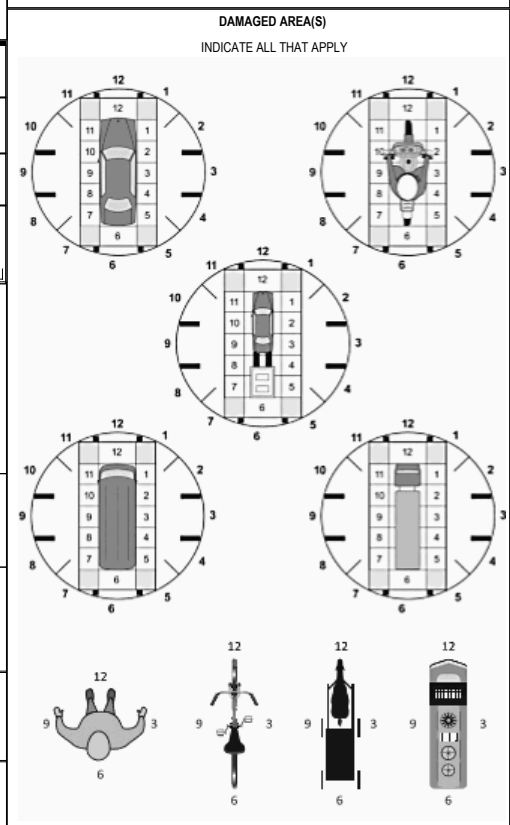

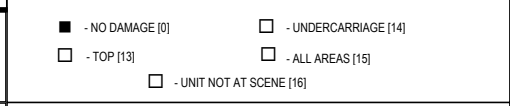
