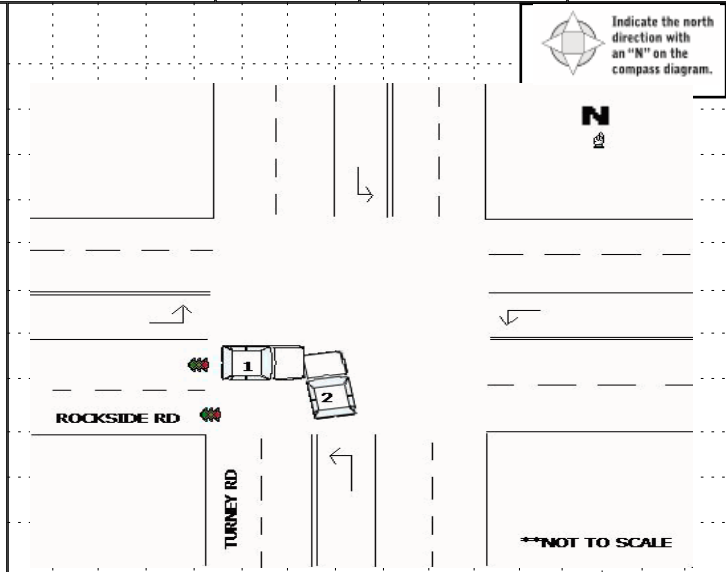

NARRATIVE

DRIVER OF UNIT 1 STATED THE FOLLOWING: HE WAS TRAVELING E/B ON ROCKSIDE IN THE LEFT LANE. THE TRAFFIC SIGNAL WAS GREEN AT THE TURNEY INTERSECTION AND HE BEGAN TO TRAVEL THRU THE INTERSECTION, AT WHICH POINT UNIT 2 MADE A LEFT TURN FROM TURNEY N/B IN FRONT OF UNIT 1. UNIT 1 THEN STRUCK THE LEFT FRONT OF UNIT 2. DRIVER OF UNIT 2 STATED THAT HE WAS TRAVELING N/B ON TURNEY AND HAD THE GREEN LEFT TURN SIGNAL AND AS HE BEGAN TO TURN LEFT ONTO ROCKSIDE, UNIT 2 WAS STRUCK BY UNIT 1, WHICH RAN THE RED LIGHT E/B ON ROCKSIDE.

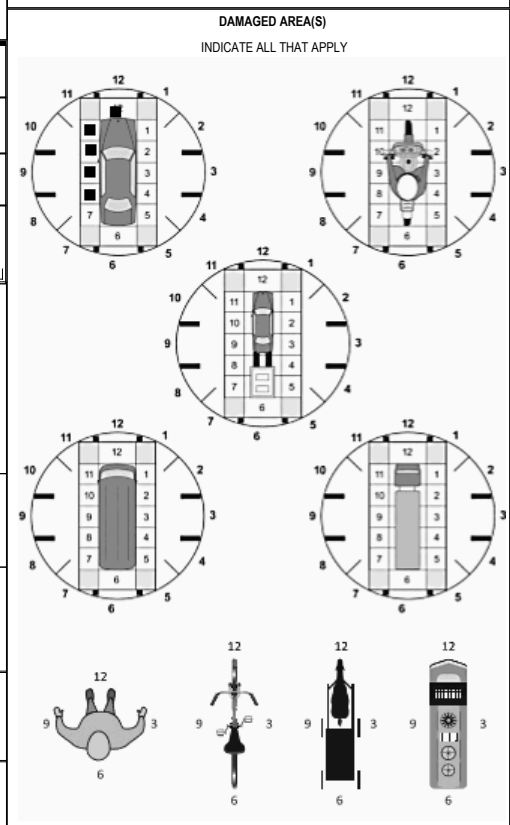

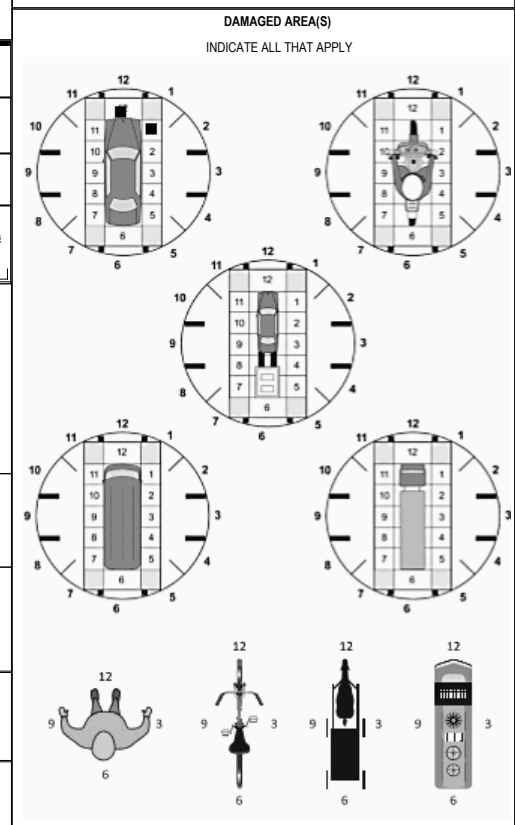
