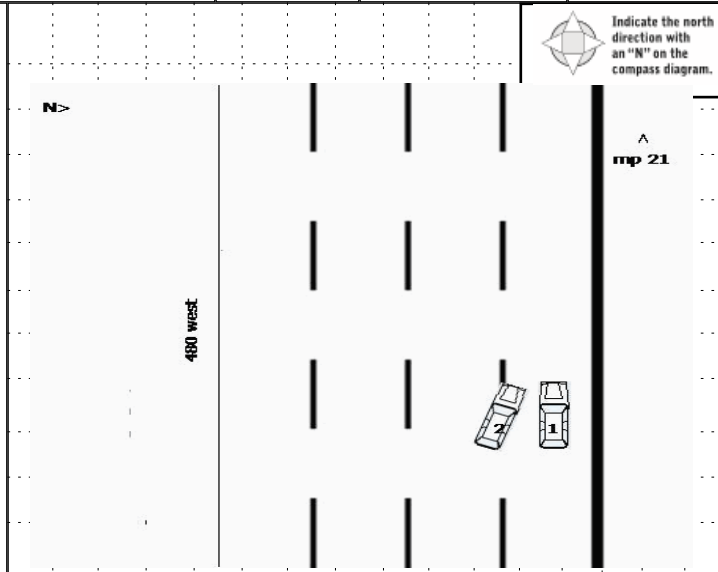

UNIT 1 WAS TRAVELING WEST ON I 480 APPROACHING MP 21 (TRANSPORTATION BLVD EXIT). UNIT TWO WAS TRAVELING NEXT TO UNIT 1 IN THE LANE JUST TO UNIT 1'S LEFT. UNIT 2 ATTEMPTED A LANE CHANGE INTO UNIT 1'S LANE, WITHOUT DUE CARE. THE RESULT WAS UNIT 2 SIDE SWIPING UNIT 1. UNIT 2 DID NOT STOP AT THE SCENE AND CONTINUED ON 480 WESTBOUND. UNIT 2 DESCRIBED AS A NEWER LINCOLN SEDAN WHITE IN COLOR.

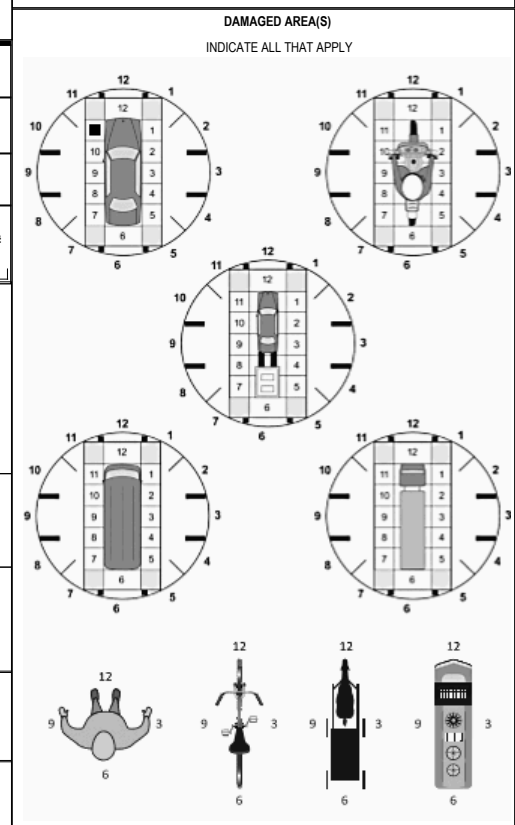
