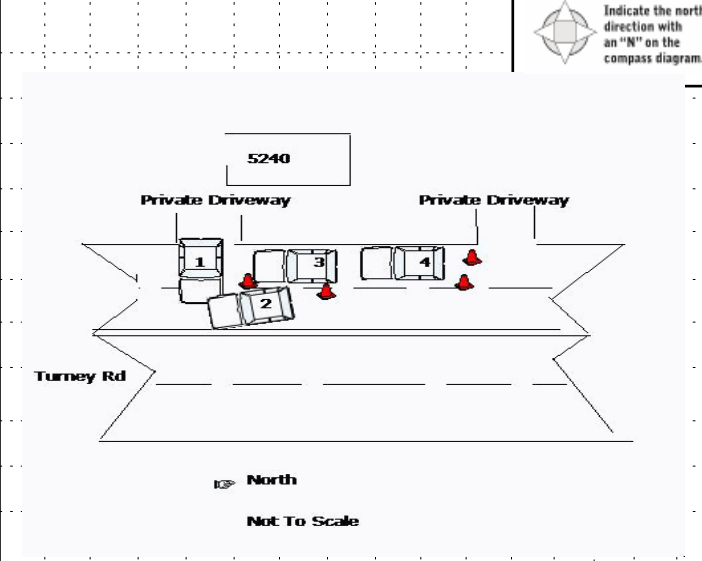

UNIT #3 AND UNIT #4 WERE NON CONTACT, FACING SOUTH, WORKING, AND LEGALLY PARKED IN A CLOSED OUTSIDE LANE AT 5240 TURNEY RD. UNIT #2 TOOK EVASIVE ACTION TO THE LEFT. AS A RESULT, THE RIGHT FRONT OF UNIT #2 COLLIDED WITH THE LEFT FRONT OF UNIT #1. ALL UNITS WERE AT FINAL REST UPON ARRIVAL.

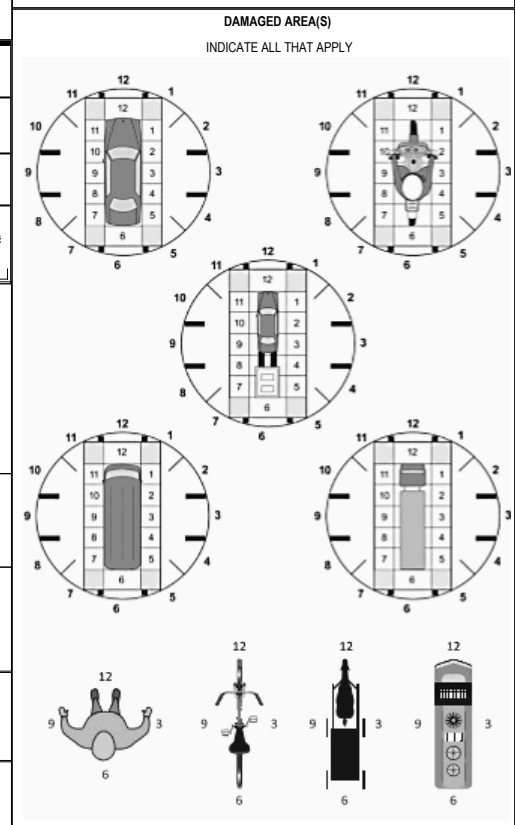

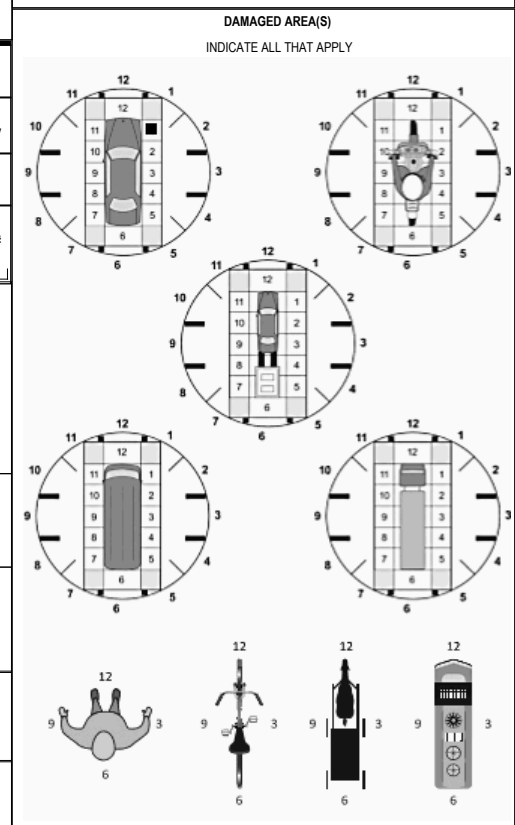


