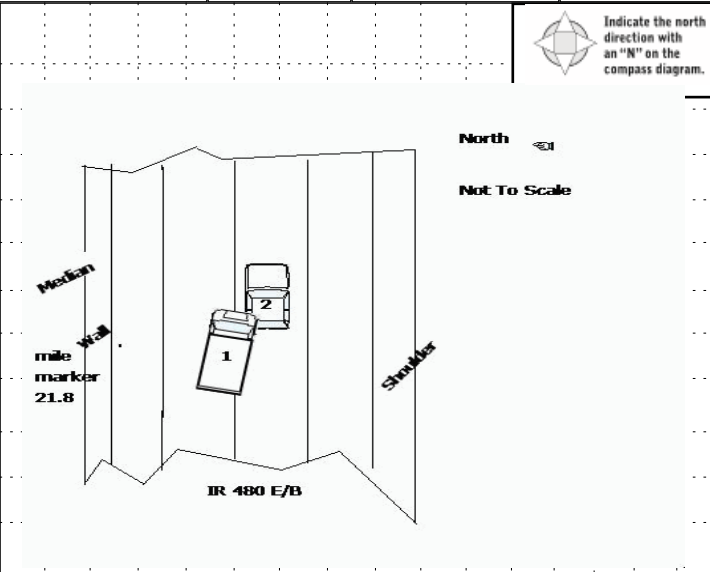

UNIT #1 WAS TRAVELING EAST ON IR 480 NEAR MILE MARKER 21.8 IN THE MIDDLE INSIDE LANE. UNIT #2 WAS TRAVELING EAST ON IR 480 NEAR MILE MARKER 21.8 IN THE MIDDLE OUTSIDE LANE. UNIT #1 ATTEMPTED TO CHANGE INTO THE MIDDLE OUTSIDE LANE. AS A RESULT, THE RIGHT FRONT OF UNIT #1 COLLIDED WITH THE LEFT REAR SIDE OF UNIT #2. UNIT #2 ROTATED COUNTER CLOCKWISE AND THE LEFT SIDE COLLIDED WITH THE FRONT OF UNIT #1. UNIT #2 CONTINUED TO ROTATE AND THE RIGHT REAR COLLIDED WITH THE LEFT FRONT OF UNIT #1. BOTH UNITS WERE MOVED FROM FINAL REST.
