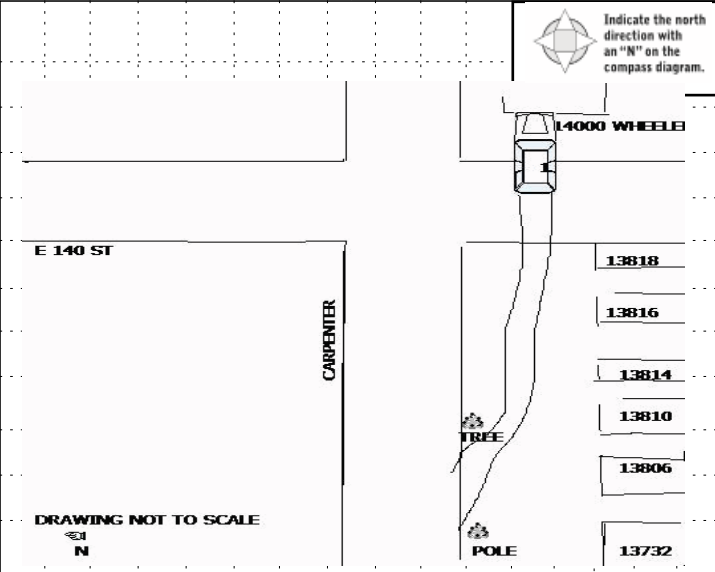

THE DRIVER OF UNIT 1 HAD A MEDICAL ISSUE WHICH CAUSED HIM TO BLACK OUT AND DOES NOT REMEMBER THE CRASH .

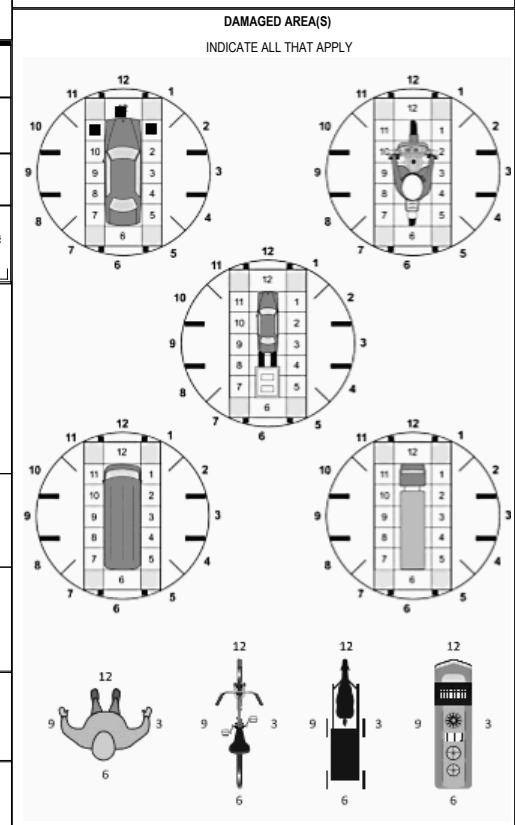
