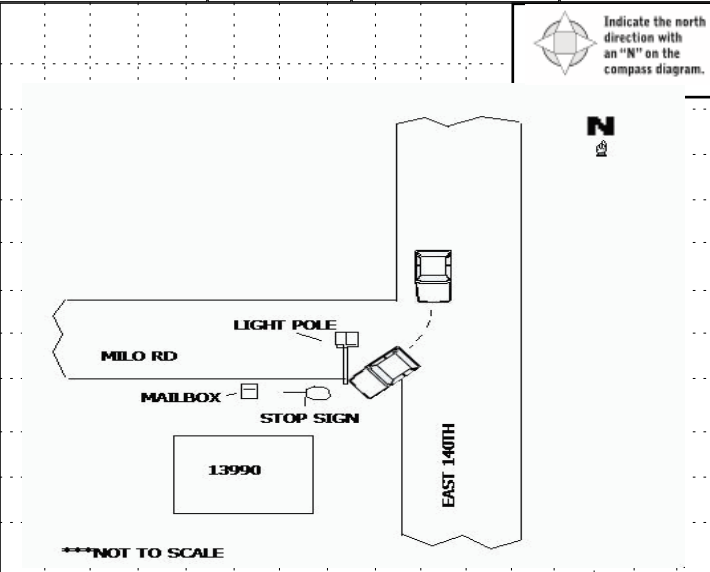

UNIT 1 WAS TRAVELING S/B ON EAST 140TH ST AND ATTEMPTED TO MAKE A RIGHT TURN ONTO MILO RD. UNIT 1 WAS DRIVING AT AN UNSAFE SPEED AND LOST CONTROL, CAUSING UNIT 1 TO DRIVE LEFT OFF THE ROADWAY. UNIT 1 THEN DROVE ONTO THE TREE LAWN OF 13990 MILO AND STRUCK A LIGHT POLE, STOP SIGN AND A MAIL BOX. ALL THREE OBJECTS WERE DAMAGED. UNIT 1 LEFT THE SCENE BUT CONTACTED POLICE AFTER ARRIVING AT HIS RESIDENCE.

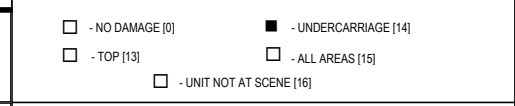
