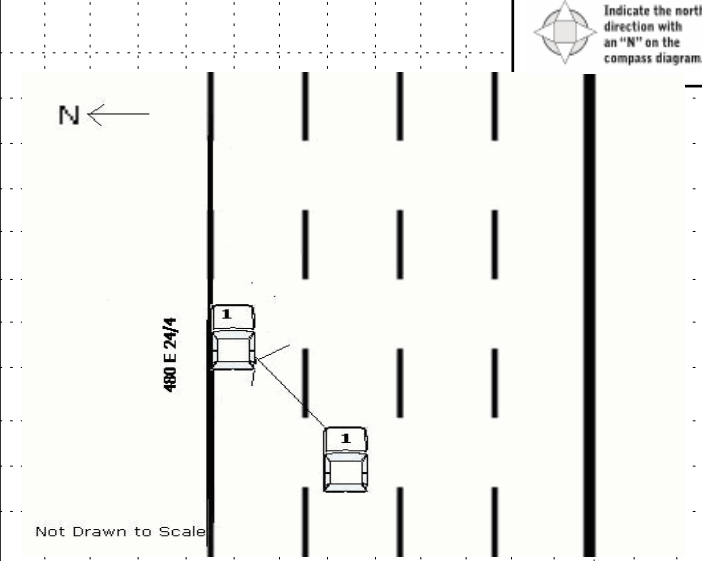

NARRATIVE
 THE DRIVER OF UNIT #1 STATED HE WAS TRAVELING ON I- 480 E BOUND IN THE SECOND LANE JUST PASS THE BROADWAY AVE ENTRANCE RAMP. THE DRIVER OF UNIT #1 STATED A VEHICLE THAT WAS TRAVELING IN THE SAME DIRECTION IN FRONT OF HIM STARTED DRIVING ERRATIC, THEN THEY SLAMMED ON THEIR BRAKES. AT THAT TIME THE DRIVER OF UNIT #1 STATED HE SNATCHED THE STEERING WHEEL TO THE LEFT TRYING TO AVOID HITTING THE VEHICLE. BUT HE LOST CONTROL HITTING THE MEDIAN CAUSING DISABLING DAMAGE TO HIS VEHICLE.

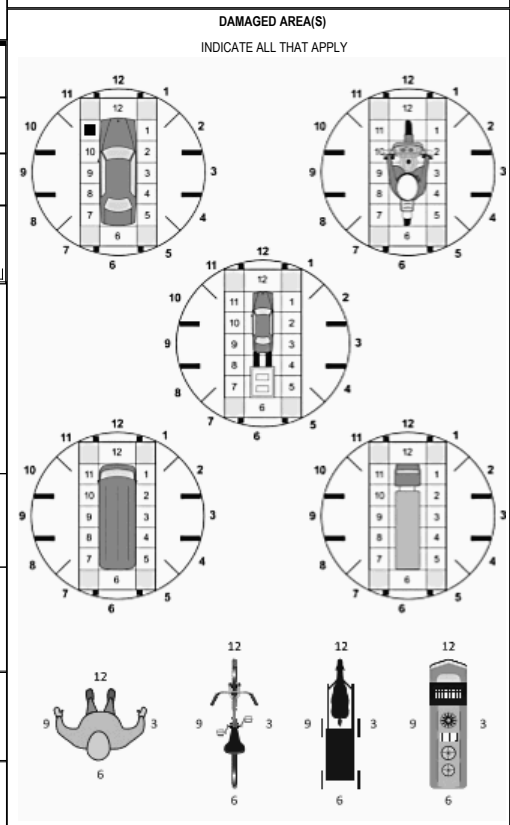
